CREATION OF POSITIONS IN THE LOCAL GOVERNMENT OF TAYTAY, RIZAL.

WHEREAS, the Sangguniang Bayan of Taytay, Rizal after a thorough
study has found credence to create the following positions:

Project Development Affairs Officer I	-	SG 11
Clerk III	-	SG 6
Social Welfare Officer V	-	SG 24
Social Welfare Officer I	-	SG 11
Five (5) Day Care Workers I	-	SG 6
Two (2) Medical Officer III	-	SG 18
One (1) Dentist II	-	SG 16
One (1) Public Health Nurse II	-	SG 16

WHEREAS, to effectively and efficiently deliver basic services to our under privileged constituents;

NOW, THEREFORE, the Sangguniang Bayan of Taytay in a session duly assembled, hereby ordains:

SECTION 1. That there is a compelling reason to create new positions in the Municipal Government of Taytay, Rizal;


SECTION 2. That the amount allotted and appropriated for the said positions be taken from the lumpsum appropriation in the Office of the Mayor;

SECTION 3. That the release of the aforesaid amount is subject to the usual accounting and auditing rules and regulations;


SECTION 4. That this Ordinance shall take effect upon approval.

ENACTED, this 25th day of March, 1999 at the Session Hall Municipal Building, Taytay, Rizal.


