ORDINANCE NO. 698 series of 2021

AN ORDINANCE IMPLEMENTING THE IATF RESOLUTION NO. 104 s. 2021 WITH ADDITIONAL INSTRUCTIONS AND RESTRICTIONS IN THE MUNICIPALITY OF TAYTAY, RIZAL

WHEREAS, the Inter-Agency Task Force (IATF) on the management of emerging infectious diseases had issued Resolution No. 104 series of 2021, on March 20, 2021 endorses to the President for his approval the placing of the National Capital Region, and the provinces of Bulacan, Cavite, Laguna, and Rizal under General Community Quarantine (GCQ) for the limited period of March 22, 2021 until April 4, 2021, subject to review upon the expiration of said period;

WHEREAS, the IATF Resolution is due to the rising active cases of COVID-19 in the National Capital Region and contiguous provinces of Bulacan, Cavite, Laguna, and Rizal this month;

WHEREAS, the Office of the President issued a Memorandum from the Executive Secretary dated March 21, 2021 regarding additional measures to address the rising cases of COVID-19 in the country, stating that the President has approved the placing of the provinces of Bulacan, Cavite, Laguna and Rizal together with the urbanized cities of the National Capital Region including the Municipality of Pateros under General Community Quarantine (GCQ) effective March 22, 2021 to April 4, 2021;

WHEREAS, to ensure continuity of the national agencies effort and measures to cascade down to the local community for implementation in battling the effect of COVID-19 Pandemic and ensure the utmost protection of the health of the constituents, a local legislation for this purpose is needed;

WHEREAS, it is but fitting and appropriate for the Sangguniang Bayan to formulate measures that will translate the national policy directions into local guidelines for this municipality regarding regulation of mobility, to better attain its avowed objectives;

NOW THEREFORE, be it ordained by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, that:

Section 1. Under IATF Resolution No. 104, s. 2021, the following additional restriction measures shall be put in place in the Municipality of Taytay, Rizal for the period of March 22, 2021 to April 4, 2021:

- 1. To prevent the transmission of COVID-19 to other parts of the country, only essential travel into and out of the Subject Area shall be allowed. Public transportation shall remain to be operational at such capacities and protocols in accordance with the guidelines issued by the Department of Transportation. The use of active transportation shall likewise be promoted;
- 2. All mass gatherings including religious gatherings shall be prohibited. The holding of face-to-face meetings are highly discouraged, and in the alternative virtual meetings are highly encouraged;
- 3. Holding of weddings, baptisms, and funeral services shall be limited to 10 persons;
- 4. Current operational capacities of essential and non-essential services / industries shall be maintained subject to adherence to safety protocols and minimum public health standards, particularly in the prohibition of aggregation in communal areas such as pantries, canteens, etc. However, the private sector is enjoined to adopt similar alternative working arrangements as those already in place in the executive branch of government, i.e. thirty percent (30%) to fifty percent (50%) operational or on-site capacity, where applicable;
- 5. Dine-in restaurants, cafes, and establishments shall be limited to delivery, take-out, and any outdoor or al fresco dining shall be allowed provided that additional engineering and administrative controls are put in place such as but not limited to, placing of acrylic or similar dividers, limiting to two persons per table with appropriate seating arrangements (one-seat apart in a diagonal configuration);
- 6. The suspension of operations of businesses / industries pursuant to IATF Resolution No. 103 issued on March 18, 2021, is hereby reiterated. The operations of driving schools, traditional cinemas and video-and interactive-game arcades, libraries, archives, museums, and cultural centers, limited social events at accredited establishments of the DOT, and limited tourist attractions except open-air tourist attractions shall be temporarily suspended. Cockfighting and cockpit operations, including in areas under Modified General Community Quarantine shall be temporarily suspended. Venue capacity of outdoor dine-in restaurants and cafes shall be reduced to a maximum of fifty percent (50%);



- 7. A common curfew shall be imposed between ten o'clock in the evening to five o'clock in the morning (10:00 PM to 5:00 AM). Workers, cargo vehicles, and public transportation, however, shall not be restricted by such curfew;
- 8. Any person below eighteen (18) years old and above sixty-five (65) years old, those with immunodeficiency, comorbidity, or other health risks, and pregnant women, including any persons who reside with the aforementioned, shall be required to remain in their residences at all times, except when indispensable under the circumstances for obtaining essential goods and services, or for work in their respective industries and offices. Persons above sixty-five (65) years old may likewise be allowed for outdoor non-contact sports and other forms of outdoor exercises; Persons with disability (PWD) may be allowed outdoors for their therapy as well as for outdoor non-contact sports and other forms of outdoor exercises, upon presentation of prescription from their physicians or presentation of PWD ID;
- 9. Visiting persons outside their immediate family or other households is strongly discouraged. Even at home, the wearing of masks for the elderly and the vulnerable and for the rest of the household, is strongly advised; and
- 10. Subject to the above additional restrictions, all provisions applicable to GCQ areas in the Omnibus Guidelines in the Implementation of Community Quarantine in the Philippines, as amended, shall remain in effect.

Section 2. Additional Instructions and Restrictions – In addition to the restrictions mentioned under Resolution No. 104, s. 2021 of the IATF the following shall likewise be implemented within the jurisdiction of the Municipality of Taytay.

- **A.** Liquor Ban The sale of all types of alcoholic drinks shall be allowed from 8:00 AM to 12:00 NN only. Consuming of any Alcoholic drinks in public places is hereby prohibited at all times.
- **B.** Public Market / All Recognized Talipapas shall be in operation from 5:00 AM to 7:00 PM only
- C. eBingo / eGames / Computer Shops / Internet Cafe operations of this establishment shall be temporarily suspended (closed)
- D. Personal Services (Salon, Barbershop and Spa) / Gym operations of this establishment shall likewise be temporarily suspended (closed)
- **E.** Contact Sports (Basketball, Volleyball, etc.) shall not be allowed for the two weeks duration of GCQ.
- **F.** Any guidelines/memorandum/advisory from the Department of Trade and Industry and other Department / Sector of the National Government pertaining to the two weeks duration of the GCO shall likewise be implemented.

Section 3. Information Dissemination — The Public Information Office of this Municipality and the Barangay shall spearhead the information dissemination of this ordinance. They are requested to have a Public Address System to effectively disseminate all enacted Ordinances in the jurisdiction of Taytay, Rizal. Official details regarding COVID-19 updates from the municipality shall come from official memorandum issued by Municipal Health Office and posted at the official page of the Taytay Public Information Office.

Additionally, the Public Information System is requested to have a hotline / call centers that will cater to the inquiries and clarifications regarding this Ordinance and COVID-19 updates in the municipality.

Section 4. Monitoring and Implementation. – the Philippines National Police (PNP-Taytay), the Local Government Unit of Taytay, all Barangay Local Government Units and all possible Force Multiplier shall monitor and implement the provisions of this ordinance.

Section 5. Penalty Clause

Individual:

- a) **First Offense** a fine of P 500 or Community Service at the Barangay where the violation occurred or lecture regarding Public Health Protocol to be conducted by the Taytay PNP shall be imposed.
- b) Second and Subsequent Offense a fine of 2,500 and/or imprisonment for 10 to 30 days at the discretion of the proper court shall be imposed.

If the violator is a minor, the procedure in Ordinance No. 694 series of 2021 shall be followed.

Establishments:

When the offender is a corporation, partnership, organization or any similar entity, the President and/or General Manager or Managing Partner and/or General Manager, or such other Officer-In-Charge with the management of the business shall be liable for the penalty herein prescribed.

Subsequent / Habitual Violations for business establishments may lead to Closure of establishments concerned to a maximum of three (3) days and revocation of Business Permit.

Section 6. Applicability Clause – All matters not covered by the provisions of this Ordinance shall be governed by the pertinent provisions of existing Resolutions, Ordinances, Guidelines and Other Related Issuances of the National Government Agencies or higher offices.

Section 7. Separability Clause - If any provision of this ordinance is held invalid or declared to be unconstitutional, the same shall not affect the validity and effectivity of the other provisions not affected thereby.

Section 8. Effectivity Clause - This ordinance shall take effect immediately and upon approval.

Section 9. Colatilla – Policies shall be stricter from time to time as the need arises. All statutes and policies by the Local Government Unit of Taytay shall be on a day-to-day basis based on the pronouncements of National Government Agencies or higher offices.
