**ORDINANCE NO. 707 series of 2021**

**APPROVING SUPPLEMENTAL BUDGET NO. 2. AN ORDINANCE  
APPROPRIATING THE AMOUNT OF SIXTY-ONE MILLION THIRTY-TWO  
THOUSAND NINE HUNDRED THIRTY-TWO PESOS AND 94/100 (PHP  
61,032,932.94) FROM THE UNAPPROPRIATED BALANCE RETAINED  
EARNINGS FY 2020 IN THE 20% DEVELOPMENT FUND AND THE  
AMENDMENT OF SEVERAL EXPENDITURE ITEMS IN THE FY 2021 20%  
DEVELOPMENT FUND TO VARIOUS PRIORITY EXPENDITURES IN THE  
MUNICIPALITY OF TAYTAY, RIZAL**

WHEREAS, Accounting Office has determined the Unappropriated Balance Retained Earnings FY 2020 which is available for Supplemental Appropriation as Php 11,032,932.94 for the 20% Development Fund;

WHEREAS, the Municipal Development Council Executive Committee approved their Resolution No. 2021 – 004 appropriating the amount of Php 11,032,932.94 from the FY 2020 Surplus of the 20% Development Fund to various projects / programs;

WHEREAS, the Municipal Development Council Executive Committee approved their Resolution No. 2021 – 003 amending the intention of the Municipal Wide COVID-19 Response / Aid to all Households;

WHEREAS, there are programs, projects and activities that needed funding for their immediate implementation;

WHEREAS, a supplemental budget is needed to address the various needs of the constituents in the Municipality;

NOW THEREFORE, the Sangguniang Bayan in session hereby decrees the approval of Supplemental Budget No. 2:


**Section 2.** That the release of the said amount shall be subject to the usual accounting and auditing rules and regulations.

ENACTED, this 15<sup>th</sup> day of June, 2021, 2:36 PM at the Session Hall of the Municipal Building, Taytay, Rizal.


