ORDINANCE NO. 837 series of 2025

AN ORDINANCE PROVIDING CASH INCENTIVES TO ALL PUBLIC ELEMENTARY & HIGH SCHOOL TEACHERS AND STATE COLLEGE & UNIVERSITY INSTRUCTORS IN THIS MUNICIPALITY TO BE GRANTED DURING THE CELEBRATION OF TEACHER'S MONTH EVERY OCTOBER OF EACH YEAR, SUBJECT TO AVAILABILITY OF FUNDS, APPLICABLE LAWS, AUDITING RULES AND REGULATIONS

WHEREAS, Section 447 (a)(l)(xi) of Republic Act 7160 or the Local Government Code of 1991 states that, "When the finance of the municipal government allow, provide for additional allowances and other benefits to judges, prosecutors, public elementary and high school teachers, and other national government officials stationed in or assigned to the municipality";

WHEREAS, Section 1 of the Republic Act 10743 declares the fifth day of October of every year as "National Teacher's Day";

WHEREAS, September 5 to October 5 of every year is celebrated as the National Teachers month to recognize the invaluable role of educators in the lives of learners that contribute to the betterment of the community;

WHEREAS, the Local Government Unit of Taytay deems it fitting to give endowment to public school teachers in the form of monetary incentive to cater to every educator in all public schools in the Municipality of Taytay as a way of thanking them for their dedication, patience, and hard work all throughout the academic year;

NOW THEREFORE, BE IT ORDAINED, by the 12th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, that:

Section 1. Title - This Ordinance shall be known as the "Taytay Teachers Month Incentives Ordinance".

- Section 2. Declaration of Policy - In accordance with the policies and principles of the Local Government of Taytay, the noble endeavors and sacrifices of each educator in nationbuilding and molding the youth for the future of the nation are hereby recognized, thus deemed it fitting to honor our modern-day heroes. A teacher's day celebration cash incentive is hereby allocated to be given to qualified educators as a sign of gratitude to them by the Local Government Unit of Taytay, Rizal.
- Section 3. Qualification - This incentive shall be for all Public Elementary, Junior and Senior High School Teachers, Public School Heads, all Public School District Supervisors, State College and State University instructors currently rendering services in the Municipality of Taytay during the celebration of the teacher's month of the current year.
- List of Qualified Recipients The DepEd Taytay Sub-Office in coordination with Public Tertiary institutions in Taytay shall provide the official list of recipients for the current academic year to the Municipal Budget Officer every July as basis of the payroll for the teacher's day incentives under this Ordinance.
- Section 5. Amount of Cash Incentive - All qualified public Elementary and High School Teachers, Public School Heads and all Public Schools District Supervisors and State College & University Instructors currently serving in the Municipality of Taytay, Rizal are hereby granted, under this Ordinance, a monetary incentive with the amount of not less than One Thousand Pesos (Php 1,000.00) or higher, if funding is available. The cash incentive shall be released during the period of the teacher's month celebration.
- Section 6. Funding - The funding for the cash incentive under this Ordinance shall be sourced annually from the General Fund under the Office of the Mayor, subject to the regular auditing rules and regulations.
- Section 7. Repealing Clause - All ordinances, rules, regulations, issuances or parts thereof, in conflict with, or contrary to the provisions of this Ordinance is hereby repealed or modified accordingly.
- Section 8. Separability Clause - If any provision of this Ordinance found to be inconsistent with any law, other provision/s or part/s thereof not so affected shall remain in full force and effect.
- Effectivity Clause This Ordinance shall take effect fifteen (15) days Section 9. after its posting in conspicuous places and in the local bulletin board.
