NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby APPROVES AND RATIFIES THE REVISED GENDER AND DEVELOPMENT (GAD) PLAN AND BUDGET 2020 AMOUNTING TO SEVENTY-TWO MILLION ONE HUNDRED FORTY-TWO THOUSAND ONE HUNDRED FIFTY-FIVE PESOS (PHP 72,142,155.00) OF THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL.
