Additionally, the group showcased the municipality’s homegrown talents at the 3rd Clicconex, a National IT Convention which was held in Taytay, Rizal and at the Travel and Trade Expo of NAITAS (National Association of Independent Travel Agencies – Philippines) which was held at the Trinoma Activity Center. They were listed as a local chapter of the Philippine Folk Dance Society in 2018 after they were invited to take part at the National Folk Dance Workshop at San Jose de Buenavista in Antique. The group also competed at the Sayaw Pinoy National Dance Competitions held at Rizal Park, representing the Municipality of Taytay. Recently, the Group was included in the list of participants on the “Dance Exchange on Air”, a program initiated by the National Commission for Culture and Arts that showcase different festivals and dance cultures across the country;
