**A RESOLUTION EARNESTLY AND RESPECTFULLY REQUESTING
HONORABLE WENDELL ELIOT AVISADO, SECRETARY, DEPARTMENT
OF BUDGET AND MANAGEMENT (DBM) TO ALLOCATE FUNDS
AMOUNTING TO TWENTY MILLION PESOS (PHP 20,000,000) FOR THE
CONSTRUCTION OF A SKATE AND BICYCLE PARK FOR THIS
MUNICIPALITY**

WHEREAS, Section 13 of the Philippine Constitution declares that "The State recognizes the vital role of the youth in nation-building and shall promote and protect their physical, moral, spiritual, intellectual, and social well-being...";

WHEREAS, there have been an increase of youth skaters and bikers in Taytay and nearby towns and there have been requests for the creation of a designated skate and bicycle park since only road lots are being utilized by skaters and bikers which can be hazardous to both the enthusiasts and passersby;

WHEREAS, skate and bicycle parks add an area for safe recreation for the youth of the area, promote physical and mental health exercises to the people and serves as an engaging outdoor environment where youth interact with one another and build vital social and interpersonal skills and skate and bicycle parks are considered positive places, which encourage civic responsibility and social skills;

WHEREAS, supporting these types of recreation and sport in effect will drive the youth away from vices and other non-productive activities hence improving the well-being not just of the youth but of the community in general;


WHEREAS, much to the desire of Local Government Unit of Taytay to create a skate and bicycle park within the Municipality, it is deterred by the insufficient funds of this LGU, hence the prayer for help and assistance from the National Government for the realization of this pressing need;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby EARNESTLY AND RESPECTFULLY REQUESTS HONORABLE WENDELL ELIOT AVISADO, SECRETARY, DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) TO ALLOCATE FUNDS AMOUNTING TO TWENTY MILLION PESOS (PHP 20,000,000) FOR THE CONSTRUCTION OF A SKATE AND BICYCLE PARK FOR THIS MUNICIPALITY.
