PROPOSED ILLUMINATION OF HIGHWAY 2000 PHASE 2, TAYTAY, RIZAL**

WHEREAS, Section 16 of RA 7160 otherwise known as the Local Government Code of 1991 states that: "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare";

WHEREAS, the Municipal Government of Taytay have a project / program entitled: "Proposed Illumination of Highway 2000 Phase 2 Taytay, Rizal" with a total project cost of Php 18,344,851.56;
