A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE HON. GEORGE RICARDO R. GACULA II TO ENTER INTO A DEED OF USUFRUCT WITH THE DEPARTMENT OF INFORMATION AND COMMUNICATION TECHNOLOGY (DICT) REPRESENTED HEREIN BY ITS SECRETARY GREGORIO B. HONASAN II, FOR THE USE OF A 90.75 SQM. OFFICE SPACE IN THE 3RD FLOOR NEW TAYTAY PUBLIC MARKET, TAYTAY, RIZAL, AS OFFICE OF THE DICT TAYTAY

WHEREAS, the Local Government of Taytay, Rizal owned the New Taytay Public Market Building where a vacant space measuring an area of 90.75 sqm. located in the 3rd floor of said building is available for use;

WHEREAS, the Department of Information and Communication Technology (DICT) has requested to occupy and use the vacant office space in the 3rd floor of New Taytay Public Market as the future site for the establishment of the DICT office:



WHEREAS, the said property will be solely used by Usufructuary within the period stated in the Deed of Usufruct;

WHEREAS, any violations of the terms and conditions in the Deed of Usufruct shall automatically revoke the agreement;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby AUTHORIZES THE LOCAL CHIEF EXECUTIVE HON. GEORGE RICARDO R. GACULA II TO ENTER INTO A DEED OF USUFRUCT WITH THE DEPARTMENT OF INFORMATION AND COMMUNICATION TECHNOLOGY (DICT) REPRESENTED HEREIN BY ITS SECRETARY GREGORIO B. HONASAN II, FOR THE USE OF A 90.75 SQM. OFFICE SPACE IN THE 3RD FLOOR NEW TAYTAY PUBLIC MARKET, TAYTAY, RIZAL, AS OFFICE OF THE DICT TAYTAY.

RESOLVED FURTHER, that the duly signed Deed of Usufruct shall be ratified first by the Sangguniang Bayan before its full implementation.

RESOLVED FURTHERMORE, to send copies of this Resolution to all concerned for their information and appropriate action.
