RESOLUTION NO. 382 series of 2021

A RESOLUTION ENDORSING THE DEVELOPMENT OF THE TALIM WIND ENERGY PROJECT OF ISLAND WIND ENERGY CORPORATION (IWEC), INCLUDING THE PROPOSED TRANSMISSION LINE COMPONENT OF THE PROJECT WHICH TRAVERSES ALONG CERTAIN AREAS WITHIN THE MUNICIPALITY OF TAYTAY, RIZAL

WHEREAS, Island Wind Energy Corporation (IWEC) was awarded by the Department of Energy (DOE) with the rights and privileges to explore and develop potential wind projects in the Province of Rizal, in accordance with Republic Act No. 9513 otherwise known as the Renewable Energy Act of 2008;

WHEREAS, the Department of Energy (DOE) thru its Energy Investment Coordinating Council, has certified that the 151.2 MW Talim Wind Power Project applied for by Island Wind Energy Corporation, is an Energy Project of National Significance (EPNS) under Pre-Development phase consistent with Republic Act No. 7638 of the Department of Energy Act of 1992, as amended;

WHEREAS, development of wind energy project in our province would certainly contribute in the national government efforts to reverse the perennial power shortages the country





is currently experiencing, lessen the dependency of our national economy on fossil fuel, environmentally friendly, generate employment and boost the local tourism industry;

WHEREAS, Island Wind Energy Corporation (IWEC), in undertaking the initiative for the development of a wind energy project at Talim Island and the construction of the proposed transmission lines component associated thereto, will necessarily have to traverse areas within this municipality; hence, a request for its endorsement and support from the Sangguniang Bayan;

WHEREAS, the Municipal Government shall not be held responsible to any liability that the wind energy project may incur in the municipality;

WHEREAS, Island Wind Energy Corporation (IWEC) shall a submit a colatilla stating their willingness to pay the necessary fees and permit in pursuit of the wind energy project to the Municipal Government;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby ENDORSES THE DEVELOPMENT OF THE TALIM WIND ENERGY PROJECT OF ISLAND WIND ENERGY CORPORATION (IWEC), INCLUDING THE PROPOSED TRANSMISSION LINE COMPONENT OF THE PROJECT WHICH TRAVERSES ALONG CERTAIN AREAS WITHIN THE MUNICIPALITY OF TAYTAY, RIZAL.

RESOLVED FURTHER, that Island Wind Energy Corporation (IWEC) shall be solely responsible to any person or entity whose real property will be traversed or adversely affected by the proposed Transmission Line Component of the project.

RESOLVED FURTHERMORE, that this resolution only endorses the wind energy project, IWEC still needs to show the Sangguniang Bayan their proof of acquisition of all locations of posts or towers, for approval of succeeding resolutions that they may require from the Sanggunian for the commencement of the project.

RESOLVED FURTHERMOST, that copies of this Resolution be furnished to Island Wind Energy Corporation (IWEC) and all offices concerned for their information and reference purposes.
