RESOLUTION RESPECTFULLY REQUESTING THE HONORABLE NINA RICCI A. YNARES, RIZAL PROVINCIAL GOVERNOR, FOR THE CONSTRUCTION OF AN EXTENSION BUILDING OF THE MUNICIPAL BUILDING, DON HILARIO CRUZ AVENUE, BARANGAY SAN JUAN, TAYTAY, RIZAL

WHEREAS, Section 16 of Republic Act 7160 otherwise known as the Local Government Code of 1991, states that every local government unit shall exercise the powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, including the construction of infrastructure facilities intended primarily to service the needs of the residents of the municipality;

WHEREAS, the Local Chief Executive, Hon. Allan Martine S. De Leon, envisions a more vibrant and revitalized brand of governance and is determined to deliver high quality and readily accessible public services to the Municipality and its constituents by having an Extension Building built / constructed at the rear of the Municipal Building, Brgy. San Juan, Taytay, Rizal;

WHEREAS, conditions and developments in the Local Government Unit of Taytay, Rizal have significantly changed and the current Taytay Municipal Building is not enough to accommodate increased demand for governmental space to better serve the Municipality and its constituents;

WHEREAS, consistent with the Executive Agenda, the 12th Sangguniang Bayan of Taytay, Province of Rizal, desirous of an effective, efficient and equitable administrative governance, fully supports the construction of an Extension Building at the rear of Taytay Municipal Building, Barangay San Juan, Taytay, Rizal;




RESOLVED FURTHER, that copies of this Resolution be forwarded to all concerned for their information and appropriate action.
