**A RESOLUTION REQUESTING CHAIRMAN JUNIE E. CUA OF THE
PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO) THRU GENERAL
MANAGER MELQUIADES ROBLES TO PROVIDE THREE (3) UNITS OF
AMBULANCE VEHICLE WITH COMPLETE LIFE SAVING DEVICES FOR
THE MUNICIPALITY OF TAYTAY, RIZAL**

WHEREAS, the Municipality of Taytay, Rizal is the 2nd Most Populous Municipality in the country and has a population of 386,451 people according to the 2020 census in five (5) barangays;

WHEREAS, one of the basic and most important services that the government extends to its people especially this time of pandemic is health services;

WHEREAS, the Municipal Health Office of Taytay has a total of seven (7) ambulance units. Two (2) of these ambulances are being used for COVID-19 patients, while the other five (5) units are being used for emergency cases and in transferring patients to other hospitals;

WHEREAS, the Taytay Emergency Hospital is currently facing an ever-increasing volume of patients and the available ambulances are not sufficient to service the needs of the populace, hence, for the prime reason of quality public service, additional ambulances are necessary to make the delivery of basic healthcare services more efficient;


WHEREAS, the Philippine Charity Sweepstakes Office (PCSO) is a government entity that can greatly cater and extend assistance to this kind of necessity by way of donating ambulance units to a local government unit;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby REQUESTS CHAIRMAN JUNIE E. CUA OF THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO) THRU GENERAL MANAGER MELQUIADES ROBLES TO PROVIDE THREE (3) UNITS OF AMBULANCE VEHICLE WITH COMPLETE LIFE SAVING DEVICES FOR THE MUNICIPALITY OF TAYTAY, RIZAL.
