WHEREAS, Title II, Chapter III, Article I, Section 444(b)(1)(vi) of Republic Act ("R.A.") No. 7160, otherwise known as the Local Government Code provides that the Municipal Mayor, upon authorization by the Sangguniang Bayan, may represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, Title II, Chapter III, Article I, Section 444(2) of R.A. No. 7160 provides that the Municipal Mayor shall enforce all laws and ordinances relative to the governance of the municipality and the exercise of its corporate powers, and implement all approved policies, programs, projects, services and activities of the municipality;

WHEREAS, Title II, Chapter III, Article I, Section 444(5) of R.A. No. 7160 provides that the Municipal Mayor shall exercise such other powers and perform such other duties and functions as may be prescribed by law or ordinance;

WHEREAS, Article II, Section 13 of the 1987 Constitution provides that the State recognizes the vital role of children and youth in nation building and shall promote and protect their physical, moral, spiritual, intellectual, and social well-being;

WHEREAS, Article XV, Section 3(2) of the 1987 Constitution states that the State shall defend the right of children to assistance, including proper care and nutrition, and special protection from all forms of neglect, abuse, cruelty, and exploitation, and other conditions prejudicial to their development;

WHEREAS, Section 33 of R.A. No. 7160 provides that all Local Government Units are encouraged to enjoin and closely coordinate their efforts, services, and resources, and to cooperate with each other for the welfare of their inhabitants;

WHEREAS, in order to properly protect the rights and promote the best interest of the children in the Municipality of Taytay, and to effectively implement the mandates vested by laws to the Municipal Government, pertaining to juvenile justice and welfare;

WHEREAS, to properly ensure the protection of the children in conflict with the law, they must be housed in a proper shelter that can provide all their needs;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby AUTHORIZES THE LOCAL CHIEF EXECUTIVE, HON. ALLAN MARTINE S. DE LEON, TO REPRESENT AND SIGN FOR THE MUNICIPAL GOVERNMENT OF TAYTAY, RIZAL IN THE MEMORANDUM OF AGREEMENT WITH THE RIZAL PROVINCIAL GOVERNMENT FOR THE CUSTODY OF CHILDREN IN CONFLICT WITH THE LAW, AND FOR OTHER PURPOSES.

RESOLVED, FURTHER, that a copy of this Resolution shall be forwarded to the Office of the Municipal Mayor, and all concerned offices in the Municipal Government of Taytay.
