WHEREAS, these personnel have functioned apolitically and have respondent to the needs of our constituents during emergency situations, vehicular or personal accidents, natural disaster responses, rescue operations and have trained and shared their knowledge to numerous volunteers; thus having them relieved from their posts will be greatly disadvantageous to our constituents and the Local Government of Taytay as this can be a matter of life and death as disasters, natural or man-made, are always imminent;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby MODESTLY REQUESTS THE MUNICIPAL MAYOR-ELECT, PUNONG BARANGAY ALLAN MARTINE S. DE LEON TO EARNESTLY CONSIDER RETAINING THOSE WHO HAVE UNDERGONE SEVERAL TECHNICAL RESCUE TRAININGS AND THOSE WHO ARE CERTIFICATE HOLDERS OF RELEVANT RESCUE TRAININGS CURRENTLY DETAILED UNDER THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE OF THIS MUNICIPALITY.
