A RESOLUTION GRANTING PERMIT TO JM'S FAIR & EXHIBITS TO OPERATE TRADE FAIR / TIANGGE / BAZAAR IN THE VICINITY OF KALAYAAN PARK IN TIME WITH THE CELEBRATION OF ST. JOHN THE BAPTIST FEAST 2022 TRADE FAIR UNTIL AUGUST 17, 2022

WHEREAS, during St. John the Baptist Feast, Hamaka Festival and Christmas Season are the most profitable time of the year for all types of businesses;

WHEREAS, trade fairs have been an integral part of the celebrations;

WHEREAS, trade fairs, tiangge or the likes has been proven to appeal to the people and always bringing in thousands of visitors to our town especially during those occasions;

WHEREAS, the 11<sup>th</sup> Sangguniang Bayan of Taytay, Rizal would like to ensure that the operations of trade fairs, tiangge or the likes are regulated and conforms with all the required cleanliness and security of the facilities;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 11<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby GRANTS PERMIT TO JM'S FAIR & EXHIBITS TO OPERATE TRADE FAIR / TIANGGE / BAZAAR IN THE VICINITY OF KALAYAAN PARK IN TIME WITH THE CELEBRATION OF ST. JOHN THE BAPTIST FEAST 2022 TRADE FAIR UNTIL AUGUST 17, 2022.

RESOLVED FURTHER, that JM's Fair & Exhibits and all stallholders shall pay corresponding fees and taxes base on existing municipal tax ordinance.

RESOLVED FURTHERMORE, that JM's Fair & Exhibits and all stallholders shall obey all regulations concerning cleanliness and peace and order; That any violations of the existing rules and regulations of this municipality concerning taxations, cleanliness, peace and order, shall be construed as reason to revoke this permit without prejudicial to any legal matter that may arise thereafter; That, approval shall not be prejudicial to any legal matter that may arise due to this grant.

RESOLVED FURTHERMOST, that copy of this Resolution be furnished to all concerned for their information and appropriate action.
