The action of the sanggunian shall be in the form of a resolution, and shall be duly approved by the mayor;

WHEREAS, the Sangguniang Bayan of Taytay, Rizal interposes No Objection to the said motion;

WHEREFORE, it is Resolved by the 12th Sangguniang Bayan of Taytay, Rizal, to adopt this Resolution to COMMENT TO THE MOTION FOR RELEASE ON RECOGNIZANCE FILED BY ACCUSED RITA RIVERA Y RIVERA IN THE ABOVE-ENTITLED CASE AND HEREBY INTERPOSES NO OBJECTION TO THE SAID MOTION.
