WHEREAS, the group remained intact despite the advent of the American War in 1899 wherein the town's church was heavily damaged and thousands of locals perished and the group later on also survived all succeeding wars and catastrophic events that hit the town;

WHEREAS, Samahang Cofradia de Taytay Inc., throughout the years has played a huge part in deepening the faith of the members of the Catholic Church within and outside of the Municipality of Taytay;

WHEREAS, this August Body also recognizes the group's contribution to the town's religious cultural identity through its longstanding practices and traditions that have been passed on from generations to generations;

WHEREAS, the Sanggunian expresses its warmest greetings to all the members of Cofradia dela Anunciata de Taytay which is celebrating this momentous milestone;


