WHEREAS, Section 5, Article II of the 1987 Constitution provides that “[t]he maintenance of peace and order, the protection of life, liberty, and property, and the promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy”;

WHEREAS, the Office of the President issued Executive Order No. 221, Series of 2003 and Executive Order No. 137, Series of 2021 which mandates the Department of Social Welfare and Development (“DSWD”) to implement crisis intervention through the Assistance to Individuals in Crisis Situation (“AICS”) Program;

WHEREAS, DSWD issued Memorandum Circular No. 16, Series of 2022 entitled, “Revised Guidelines for the Implementation of the Assistance to Individuals in Crisis Situation” which provides different disbursement strategies including transfer of AICS funds to Local Government Units;

WHEREAS, Section 16 of Republic Act (“R.A.”) No. 7160, otherwise known as the Local Government Code states that, “[e]very local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”;

WHEREAS, to ensure the expeditious implementation of the AICS Program, the Municipal Government of Taytay in partnership with the DSWD, will provide cooperation

mechanisms in accordance with DSWD Memorandum Circular No. 16, Series of 2022 through a Memorandum of Agreement;


WHEREAS, consistent with the goal of providing *Serbisyong May Ngiti* to all Taytayefños, the signing of said Memorandum of Agreement is hereby necessary;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 12<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby AUTHORIZES THE MUNICIPAL MAYOR, ALLAN MARTINE S. DE LEON, MPA, TO REPRESENT AND SIGN FOR THE MUNICIPAL GOVERNMENT OF TAYTAY, PROVINCE OF RIZAL, A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT REPRESENTED BY ITS REGIONAL DIRECTOR BARRY R. CHUA, M.D., FOR THE DISBURSEMENT OF ASSISTANCE TO INDIVIDUALS IN CRISIS SITUATION (“AICS”) FUNDS IN THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL.


