A RESOLUTION REQUESTING THE HON. MAYOR ALLAN MARTINE S. DE LEON, MPA TO ENTER INTO A CONTRACT OF USUFRUCT WITH THE DEPARTMENT OF EDUCATION, THROUGH UNDERSECRETARY EPIMACO V. DENSING III, REGARDING THE PROPERTY OF THE MUNICIPALITY LOCATED AT ST. ANTHONY SUBDIVISION UNDER TAX DECLARATION NO. 18-TY-001-12440 FOR THE CONSTRUCTION OF A NEW SCHOOL BUILDING FOR NATIONAL HIGH SCHOOL AND GIVING HIM AUTHORITY TO SIGN THE SAID CONTRACT FOR THE SAID PURPOSE

WHEREAS, currently the school building for new National High School is insufficient vis-a-vis number of enrollees;

WHEREAS, some school officials of different high schools have raised their problem and concerns about the shortage of classrooms to Department of Education Undersecretary Epimaco V. Densing III when he visited some schools in Taytay, Rizal sometime on June 2023;

WHEREAS, the safety and security of the students in times of emergency might be at a greater risk if the classrooms are allowed to be used in excess of their capacity;

WHEREAS, the municipality has a property located at St. Anthony Subdivision with an area of Two Thousand (2,000) square meters that can be used as the site for another school building for a National High School;

WHEREAS, the said school building may be constructed by the Department of Education upon proper request;

WHEREAS, Section 22 of the Local Government Code provides that unless otherwise provided in the said law, no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the Sanggunian concerned;

WHEREAS, under Section 444 of the said code the Municipal Mayor shall sign contracts in behalf of the municipality upon authorization by the Sangguniang Bayan;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 12<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in session duly assembled, to REQUEST THE HON. MAYOR ALLAN MARTINE S. DE LEON, MPA TO ENTER INTO A CONTRACT OF USUFRUCT WITH THE DEPARTMENT OF EDUCATION, THROUGH UNDERSECRETARY EPIMACO V. DENSING III, REGARDING THE PROPERTY OF THE MUNICIPALITY LOCATED AT ST. ANTHONY SUBDIVISION UNDER TAX DECLARATION NO. 18-TY-001-12440 FOR THE CONSTRUCTION OF A NEW SCHOOL BUILDING FOR NATIONAL HIGH SCHOOL AND GIVING HIM AUTHORITY TO SIGN THE SAID CONTRACT FOR THE SAID PURPOSE.

RESOLVED FURTHER, that the duly signed Contract of Usufruct with the Department of Education shall be ratified first by the Sangguniang Bayan before its full implementation.

RESOLVED FURTHERMORE, that the copies of this Resolution be furnished to the Office of Education Undersecretary Epimaco V. Densing III and other concerned offices.
