A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. ALLAN MARTINE S. DE LEON, MPA, TO NEGOTIATE AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HUMAN SETTLEMENTS AND URBAN DEVELOPMENT (DSHUD) SATELLITE OFFICE, REPRESENTED BY REGIONAL DIRECTOR ATTY. JECK OTTERO, AND FOR OTHER PURPOSES

WHEREAS, Section 17(b)(viii) of R.A. No. 7160 otherwise known as the Local Government Code provides the state to provide “[s]uch basic services and facilities include, but are not limited to, programs and projects for low-cost housing and other mass dwellings, except those funded by the Social Security System (SSS), Government Service Insurance System (GSIS), and the Home Development Mutual Fund (HDMF); Provided, That national funds for these programs and projects shall be equitably allocated among the regions in proportion to the ratio of the homeless to the population”;

WHEREAS, Sangguniang Bayan Resolution No. 151 series of 2023, adopted on the 18th of January 2023, granted the authority to the Municipal Mayor Allan Martine S. De Leon to sign and enter into a Memorandum of Agreement for the Pambansang Pabahay Para sa Pilipino (“4PH”) Program with the Department of Human Settlements and Urban Development (DHSUD), represented by Secretary Jose Rizalino Acuzar;

WHEREAS, the Municipal Government of Taytay, in its capacity as the lead entity in the 4PH Program in the Municipality of Taytay and in its endeavor to sustain said program, deems it necessary to render the process accessible to the residents of Taytay, given that the regional office is situated in Laguna;

WHEREAS, the Municipal Government also requires substantial support from DHSUD, necessitating continuous communication to ensure the effective execution and to facilitate the timely completion of the 4PH program;

WHEREAS, the Municipal Government of Taytay, represented by its Municipal Mayor, Allan Martine S. De Leon, shall be authorized to negotiate with the DHSUD through its Satellite Office, represented by Regional Director Atty. Jeck Ottero;

WHEREAS, consistent with the goal of providing *Serbisyong May Ngiti* to all Taytayefios through prompt and utmost public service, this Sangguniang Bayan Resolution is being issued;


NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby AUTHORIZES THE MUNICIPAL MAYOR, HON. ALLAN MARTINE S. DE LEON, MPA, TO NEGOTIATE AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HUMAN SETTLEMENTS AND URBAN DEVELOPMENT (DSHUD) SATELLITE OFFICE, REPRESENTED BY REGIONAL DIRECTOR ATTY. JECK OTTERO, AND FOR OTHER PURPOSES.

RESOLVED FURTHER, that the duly signed Memorandum of Agreement between the Municipal Government of Taytay and DHSUD shall be ratified first by the Sangguniang Bayan before its full implementation.


RESOLVED FURTHERMORE, that copies of this Resolution be furnished to all Offices concerned for their information and appropriate action.
