WHEREAS, there are newly elected Local Youth Development Council and incoming Sangguniang Kabataan (SK) Secretaries and Treasurers in the Municipality of Taytay, Province of Rizal;

WHEREAS, Section 28 of Republic Act (RA) No. 10742, as amended by RA No. 11768, mandates “The Sangguniang Kabataan (SK) Officials and Local Youth Development Council (LYDC) Members to undergo mandatory training programs before assumption of office”, to ensure that youth leaders are well-equipped with the necessary skills and knowledge to serve their communities effectively;

WHEREAS, the modified guidelines in the conduct of the mandatory training for the Sangguniang Kabataan Officials and Local Youth Development Council (LYDC) members pursuant to Republic Act No. 10742, section 29 as amended by Republic Act No. 11768 states that the Roles, Responsibilities, and Requirements of the Provincial Governor are to provide counterpart funds for the conduct of the Mandatory Training, direct the Accredited Youth Development Officer and/or staff to convene the Training Team, and ensure to performance the specified duties, and responsibilities under these guidelines, and mobilize additional LGU staff to be part of the management team or training teams;

WHEREAS, the Sangguniang Kabataan Federation of the Municipality Taytay is committed to the development and empowerment of young leaders;

WHEREAS, there are newly elected Local Youth Development Council members and incoming SK Secretaries and Treasurers, and no other mandatory training sessions scheduled in the Municipality of Taytay at this time;

WHEREAS, the SK Federation of Rizal, Local Youth Development Office from different municipalities and the Provincial Youth Development is proactively organizing this event for the benefit of the youth;

WHEREAS, the training will involve participants from seven (7) Municipalities in Rizal, specifically Taytay, Angono, Baras, San Mateo, Morong, and Cardona, with each municipality sending 25 participants, a total of 175 participants, but not limited to these municipalities;


WHEREAS, the SK Federation of Rizal seeks the support of the Provincial Governor to ensure the success of this training by providing a suitable venue;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12<sup>th</sup> Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby RESPECTFULLY REQUESTS THE HONORABLE GOVERNOR NINA RICCI A. YNARES FOR SUPPORT IN THE CONDUCT OF THE LOCAL YOUTH DEVELOPMENT COUNCIL AND INCOMING SK SECRETARIES AND TREASURERS MANDATORY TRAINING.

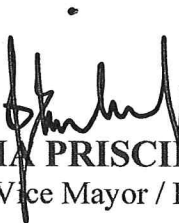
RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action.
