WHEREAS, the Office of Punong Barangay of Barangay San Isidro submitted to the Sangguniang Bayan for review a copy of Barangay Ordinance 003 s. 2024 entitled: "An Ordinance Amending Sections II, III, IV, V and VI of Barangay Ordinance 008-2021 or the Barangay Revenue Code of 2021";

WHEREAS, the aforementioned statute has undergone the review of the Committee on Rules, Resolutions, and Ordinances to check on the merits of the pronouncement from the Barangay's Local Government Unit;

WHEREAS, after a thorough discussion and deliberation, it was agreed upon by the Committee members to approve the said ordinance as prescribed in the adopted Committee Report of the Committee on Rules, Resolutions, and Ordinances;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 12th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby APPROVES IN REVIEW THE BARANGAY ORDINANCE NO. 003-2024 OF BARANGAY SAN ISIDRO.

RESOLVED FURTHER, that copies of this Resolution and the approved Committee Report of the Committee on Rules, Resolutions, and Ordinances be furnished to the Sangguniang Barangay concerned for their information and appropriate action.
