DE LEON, MPA, TO NEGOTIATE, SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT FOR BIRTH REGISTRATION ASSISTANCE PROJECT PROGRAM WITH PHILIPPINE STATISTICS AUTHORITY, REPRESENTED HEREIN BY ITS REGIONAL DIRECTOR, CHARITO C. ARMONIA, IN THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL

WHEREAS, Section 2 of Republic Act ("R.A.") No. 11055, otherwise known as "Philippine Identification System Act" states that, "it is hereby declared the policy of the State to establish a single national identification system referred to as the "Philippine Identification System" or the "PhilSys" for all citizens and resident aliens of the Republic of the Philippines to promote seamless delivery of service, to improve the efficiency, transparency, and targeted delivery of public and social services, to enhance administrative governance, to reduce corruption and curtail bureaucratic red tape, to avert fraudulent transactions and misrepresentations, to strengthen financial inclusion, and to promote ease of doing business. Towards this end, a resilient digital system shall be deployed to secure the data collected and ensure that the people's right to privacy, confidentiality and other basic rights are at all times upheld and protected";

WHEREAS, Section 6(c) of R.A. No. 10625, otherwise known as "Philippine Statistical Act of 2013", mandates to "collect, compile, analyze, abstract and publish statistical information relating to the country's economic, social, demographic, political affairs and general activities and condition of the people";

WHEREAS, Article 16(c), Rule 11, Title I of Implementing Rules and Regulations of R.A. No. 10625 states to "provide overall direction in the implementation of the Civil Registry Law and related issuances and exercise technical supervision over the civil registrars as Civil Registrar General";

WHEREAS, the Municipal Government of Taytay shall enter into a Memorandum of Agreement ("MOA") with Philippine Statistics Authority to increase birth registration rates, particularly among marginalized communities, by providing free and accessible services to help individuals secure a legal identity for all Taytayeño constituents;



WHEREAS, consistent with the goal of providing *Serbisyong May Ngiti* to all Taytayeños, the negotiation of MOA with Philippine Statistics Authority will strengthen the mission of the Municipal Government to meet the needs of its inhabitants;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 13th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, to AUTHORIZE THE MUNICIPAL MAYOR, ALLAN MARTINE S. DE LEON, MPA, TO NEGOTIATE, SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT FOR BIRTH REGISTRATION ASSISTANCE PROJECT PROGRAM WITH PHILIPPINE STATISTICS AUTHORITY, REPRESENTED HEREIN BY ITS REGIONAL DIRECTOR, CHARITO C. ARMONIA, IN THE MUNICIPALITY OF TAYTAY, PROVINCE OF RIZAL.

RESOLVED FURTHER, that the duly signed Memorandum of Agreement shall be ratified first by the Sangguniang Bayan before its full implementation.

RESOLVED FINALLY, that copies of this Resolution be forwarded to the Office of the Municipal Mayor, and all concerned offices in the Municipal Government of Taytay.
