WHEREAS, on January 25, 2025, PLTCOL SOLERO successfully led a highrisk hostage negotiation along C6 Road, Brgy. Sta. Ana, Taytay, Rizal, which resulted in the safe rescue of a one-year-old child taken hostage, demonstrating unwavering composure, selflessness, and leadership in the face of imminent danger;

WHEREAS, his heroic conduct and decisive actions reflect the highest traditions of valor and service of the Philippine National Police, bringing great honor and pride to the Municipality of Taytay and inspiring his fellow officers and the community he serves;

WHEREAS, this distinction underscores PLTCOL. SOLERO's unwavering commitment to his oath "To Serve and Protect", and his genuine dedication to preserving peace and public order;
