## ORDINANCE NO. 849 series of 2025

## AN ORDINANCE GRANTING CASH INCENTIVES TO ATLETANG TAYTAYEÑOS FOR EVERY GOLD, SILVER OR BRONZE MEDAL/S WON IN THE ANNUAL PALARONG PAMBANSA AND FOR OTHER PURPOSES

WHEREAS, Section 19, Article XIV of the 1987 Philippine Constitution provides that "the State shall promote physical education and encourage sports programs, league competitions, and amateur sports, including training for international competitions, to foster self-discipline, teamwork, and excellence for the development of a healthy and alert citizenry";

WHEREAS, Section 3("a") of the Republic Act 10588, also known as the Palarong Pambansa Act of 2013, states that one of its objectives is to institutionalize the Palarong Pambansa as the premier national sporting event of the country under the Department of Education (DepEd) as venue for talent identification, selection, and recruitment of student athletes;

WHEREAS, each Palarong Pambansa will gather student-athletes from 17 athletic associations representing the 17 regions of the Philippines to compete in various sporting events;

WHEREAS, these Atletang Taytayeño Medalists together with their coaches and trainers that have brought pride and honor not just to the Municipality of Taytay and the Province of Rizal but to the whole Region IV-A as well, deserves this commendation and incentives;

WHEREAS, the Local Government Unit of Taytay deems it fitting to give cash incentives to all Atletang Taytayeño Medalists, together with their coaches and trainers in each annual Palarong Pambansa as a way of rewarding them for bringing pride and honor not just to the Municipality of Taytay and the Province of Rizal but to the whole Region IV-A as well;

NOW THEREFORE, BE IT ORDAINED, by the 12th Sangguniang Bayan of Taytay, that:

Section 1. Title - This Ordinance shall be known as the "Palarong Pambansa Incentives Ordinance".

- **Section 2. Declaration of Policy -** It is in accordance with the policies and principles of the Local Government of Taytay to recognize and celebrate the achievements and dedication of the athletes, coaches, and trainers and to encourage and motivate them to continue striving for excellence through this recognition.
- **Section 3. Qualification** This incentive shall be for the student-athletes, coaches and trainers from the Municipality of Taytay, Province of Rizal who have brought pride and honor to Taytay by winning gold, silver and/or bronze medals in the annual Palarong Pambansa.
- **Section 4. Amount of Cash Incentive -** The amount to be given for each medal won by the student-athlete and for each sport for the coaches and trainers shall be determined and approved by the Office of the Mayor subject to availability of funds.
- **Section 5. Funding** The cash incentive under this Ordinance shall be sourced from the General Fund of the Annual Budget of the Local Government of Taytay, Rizal.
- **Section 6.** Repealing Clause All ordinances, rules, regulations, issuances or parts thereof, in conflict with or contrary to the provisions of this Ordinance are hereby repealed or modified accordingly.
- **Section 7. Separability Clause -** If any provision of this Ordinance is found to be inconsistent with any law, other provision/s or part/s thereof not so affected shall remain in full force and effect.
- **Section 8. Effectivity Clause -** This Ordinance shall take effect fifteen (15) days after its posting in conspicuous places and in the local bulletin board.
