#### **RESOLUTION NO. 52**

**A RESOLUTION REQUESTING MR. ALFONSO CHUA, OF AC  
EQUITIES RIGHTFUL OWNER OF A PARCEL OF LAND  
LOCATED AT CABRERA ROAD HAPAY NA MANGGA,  
BARANGAY DOLORES, TAYTAY, RIZAL TO GIVE ANOTHER  
EXTENSION OR CONSIDERATION OF AT LEAST TWO (2)  
MONTHS TO THE RESIDENTS OF NAGKAKAISANG HAPAY  
NEIGHBORHOOD ASSOCIATION INCORPORATED (NHNAI)  
TO VACATE SAID PROPERTY**

WHEREAS, the residents of Nagkakaisang Hapay Neighborhood Association Inc., (NHNAI) were displaced due to a court order issued by the Municipal Trial Court of Taytay, Civil Case No. 1847, effective February 28, 2006;

WHEREAS, Mr. Alfonso Chua, owner of the property had given the residents numerous opportunity to relocate and extended the grace period until July 29, 2006;

WHEREAS, the Municipality of Taytay, in furtherance of the objectives of its programs for human settlements declared and proclaimed certain parcels of land within Don Enrique Heights Subdivision as priority resettlement areas;

WHEREAS, the Municipality of Taytay needs to identify, classify and apportion parcels of land for the benefit of its informal settlers and other displaced residents, within limits of law and its municipal mandate, to the lawful satisfaction of the land owner or its assigns;

NOW THEREFORE RESOLVED, the Sangguniang Bayan duly assembled in session hereby request Mr. Alfonso Chua, of AC Equities rightful owner of parcels of land located at Cabrera Road, Hapay na Mangga, Barangay Dolores, Taytay, Rizal to give another extension or consideration of at least two (2) months to the residents of Nagkakaisang Hapay Neighborhood Association Inc. (NHNAI).

RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action.

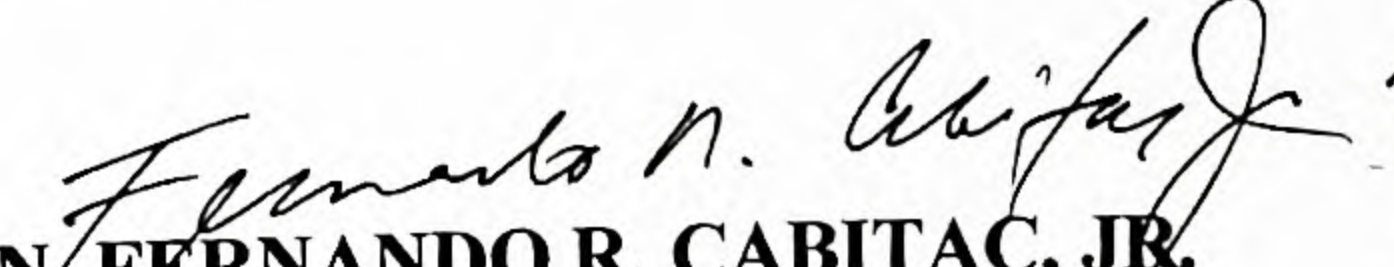

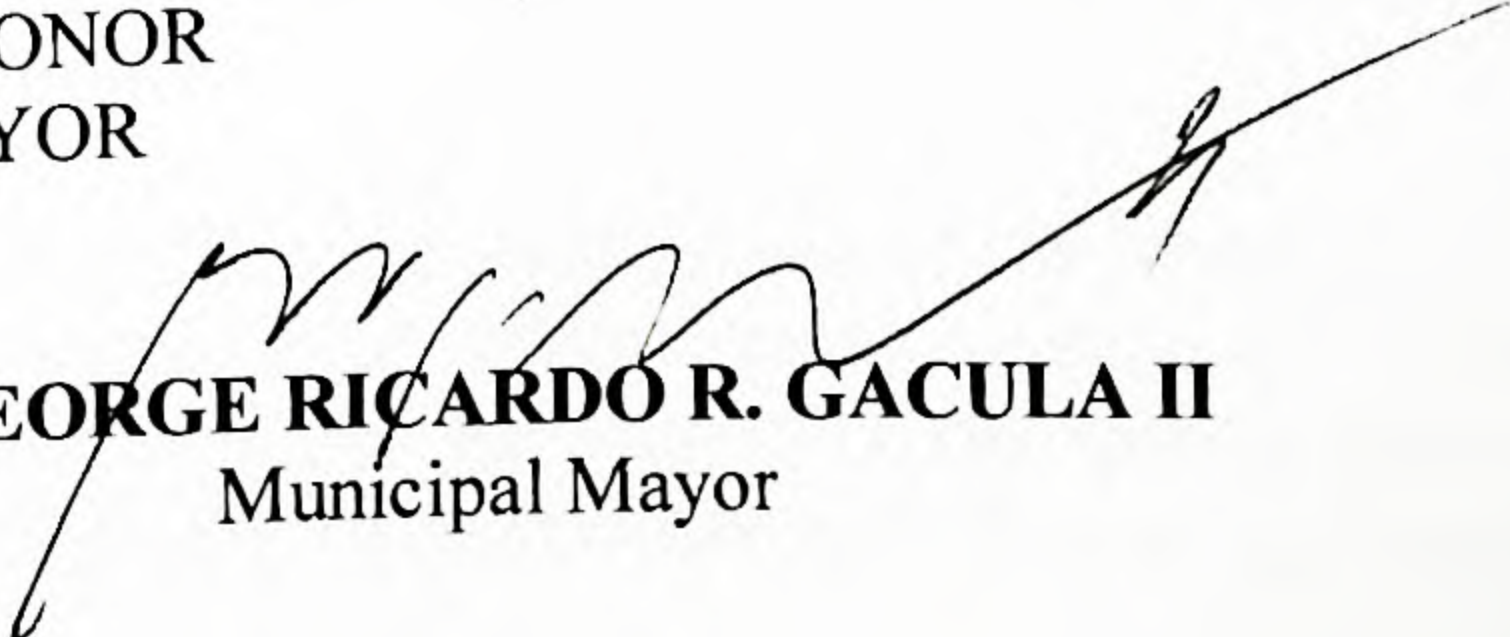
