ADOPTED, this 31st day of July 2006 at the Session Hall of the Municipal Building, Taytay, Rizal.

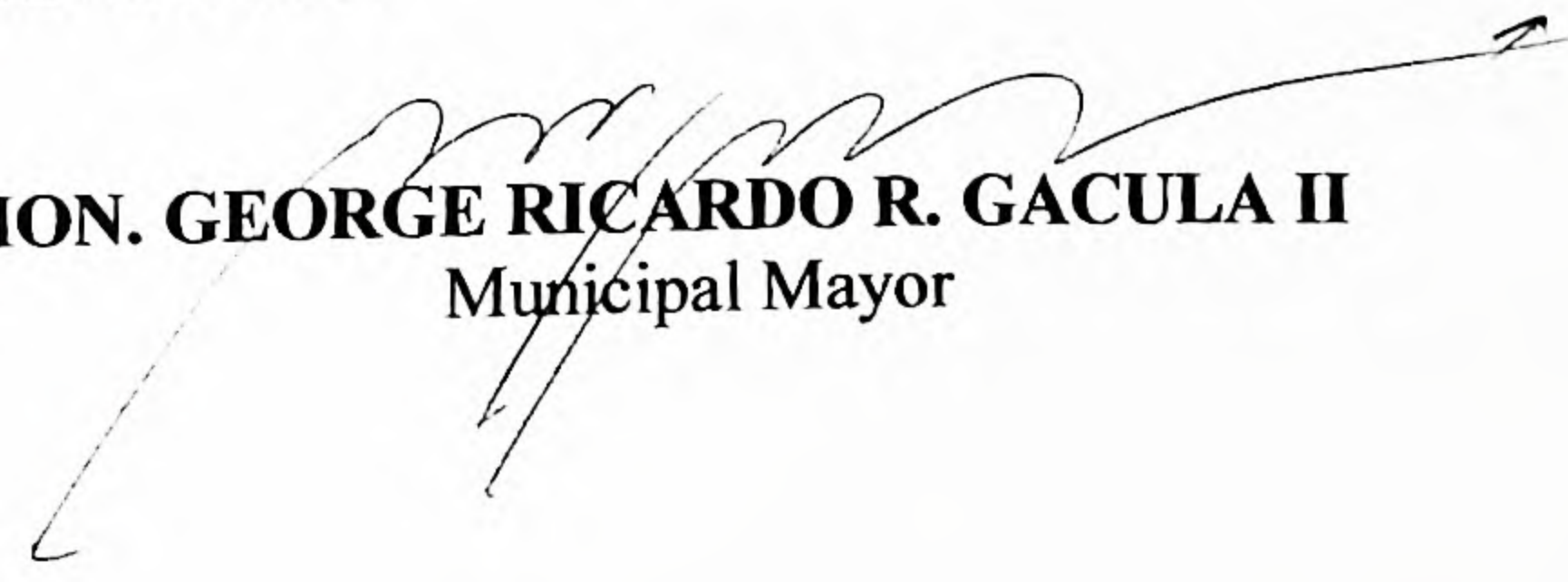
