WHEREAS, in his earnest desire to serve a great number of constituents he was then elected also as Board Member of Rizal Province from 2004 up to present;

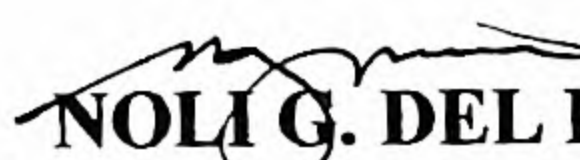
WHEREAS, the untimely death of a dignified great man, a humble yet highly principled legislator have left a stature in the Legislative Body worth inspiring;

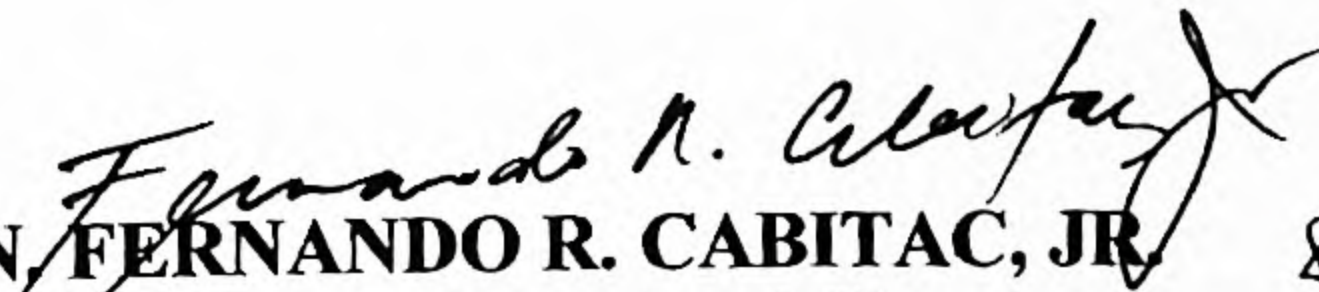
