WHEREAS, the construction of such will ease the traffic, and intensify campaign for the continuous and better services to our constituents;

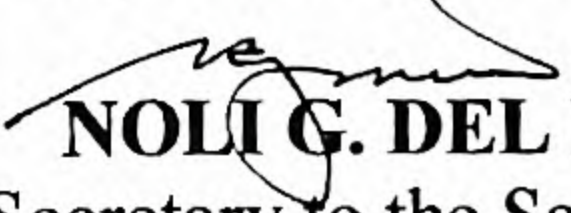
WHEREAS, the Municipal Government of Taytay, Rizal cannot support financially the said project because of the lack of fund needed;

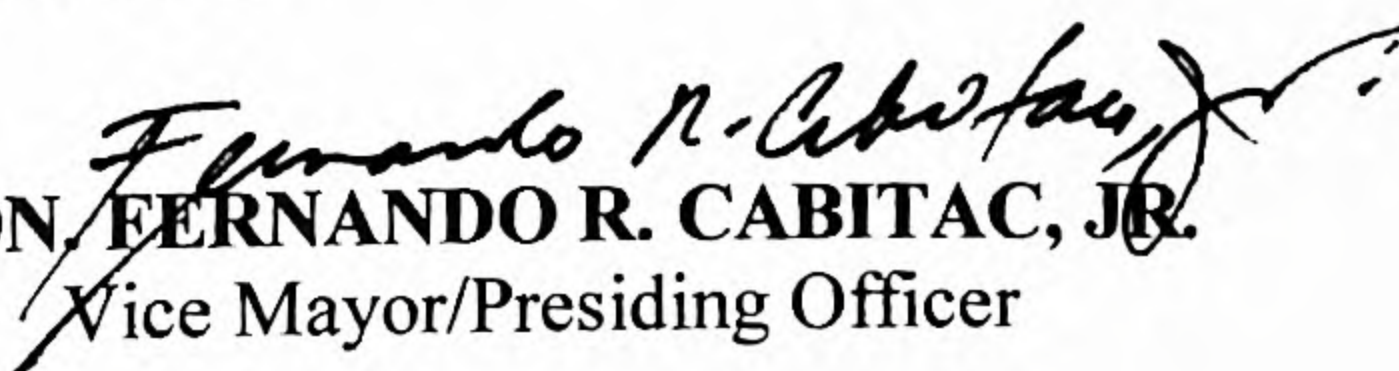
RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action;

ADOPTED this 4th day of September 2006 at the Session Hall, Municipal Building, Taytay, Rizal.

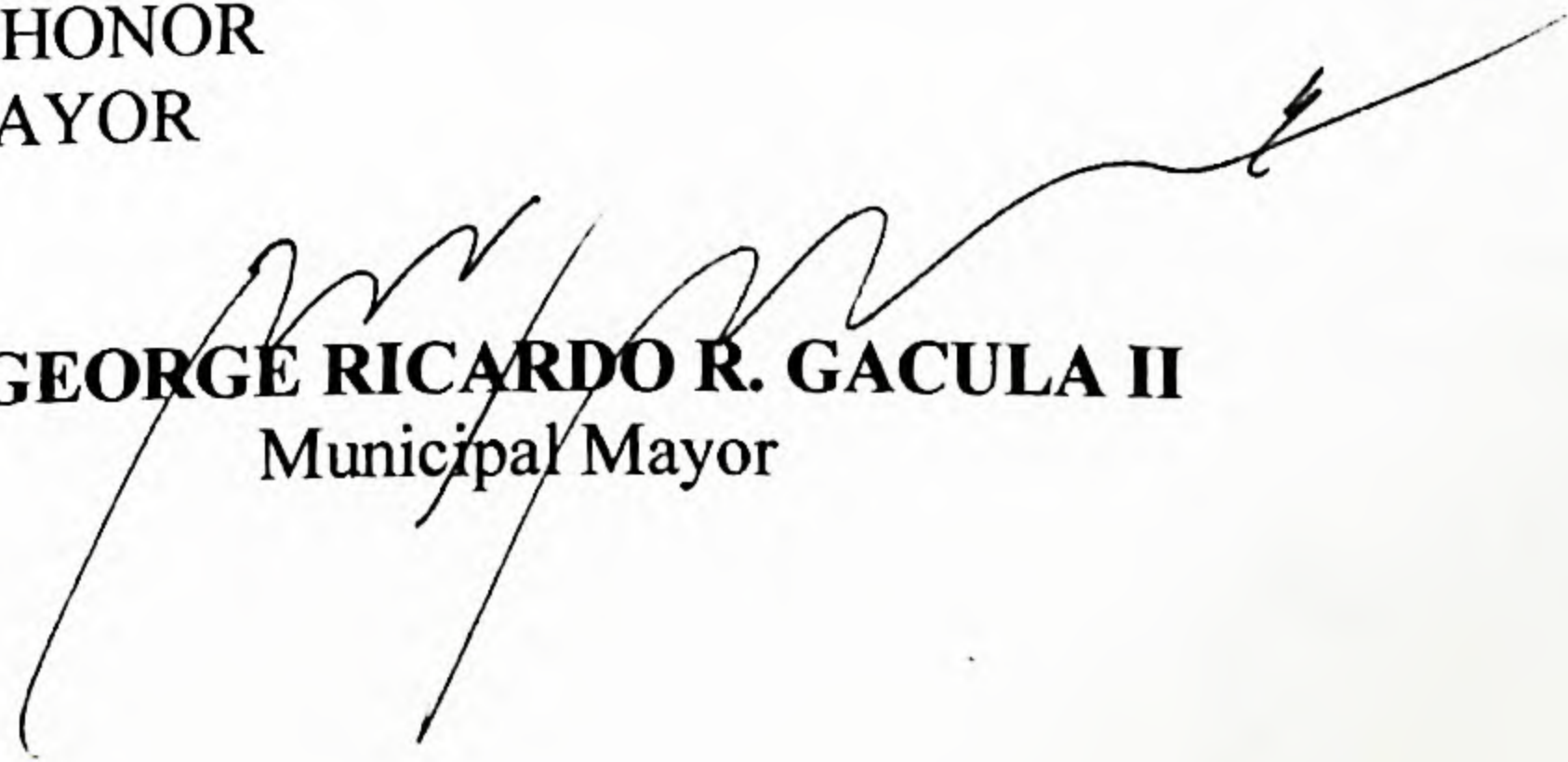
