WHEREAS, based on the evaluation of MERALCO, headed by its Manager and Head, Cainta Branch – Mr. Leonardo R. delos Reyes, that there's a need to established fund for line extension and installation of

additional Meralco facilities in the amount of Two Hundred Sixty Six Thousand One Hundred Thirty Six Pesos and 55/100 (P266,136.55);

WHEREAS, it is imperative to put up such electrification on the said area to avoid accidents and unnecessary incidents;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved the Sangguniang Bayan of Taytay, Rizal duly assembled in session, hereby authorizes to charge the amount of Two Hundred Sixty Six Thousand One Hundred Thirty Six Pesos and 55/100 (P266,136.55) to Annual Budget 2006 for the Electrical Installation for the Electrification Program of E. Mateo Street, Barangay Sta. Ana, Taytay, Rizal;

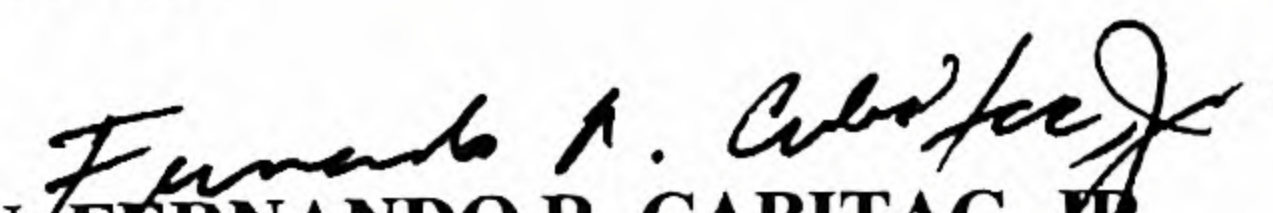
RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action;

ADOPTED this 4th day of September 2006 at the Session Hall, Municipal Building, Taytay, Rizal.

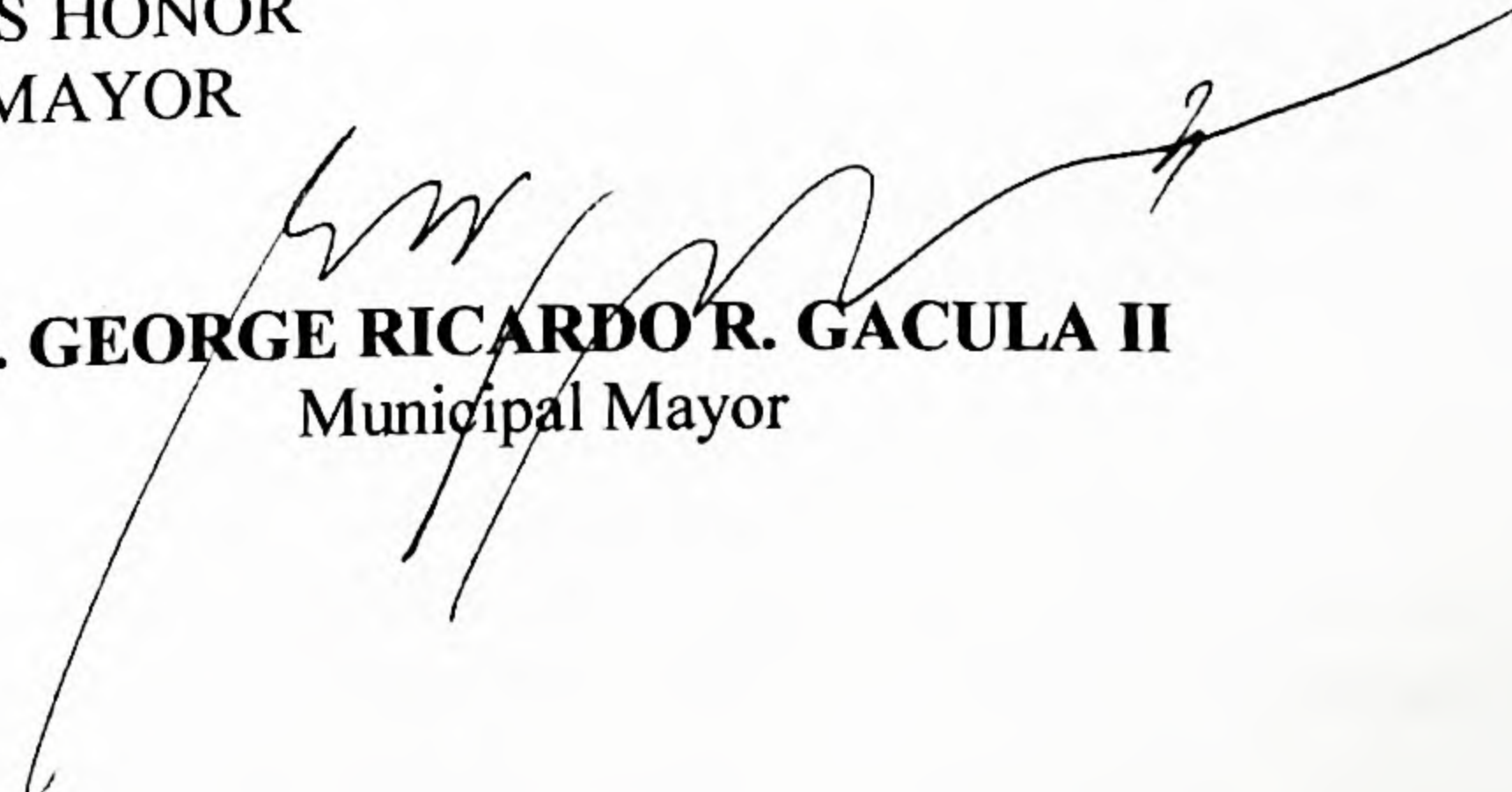
