JUNCTION IMPROVEMENT THROUGH METRO MANILA

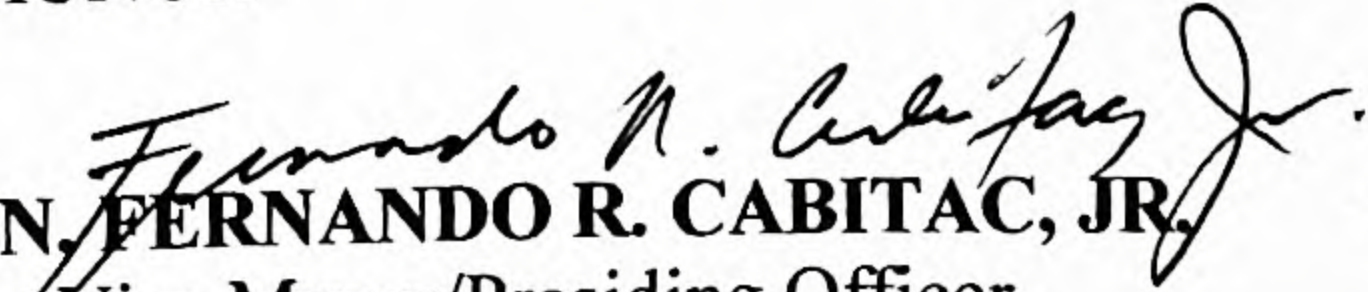
RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action;

ADOPTED this 11th day of September 2006 at the Session Hall, Municipal Building, Taytay, Rizal.

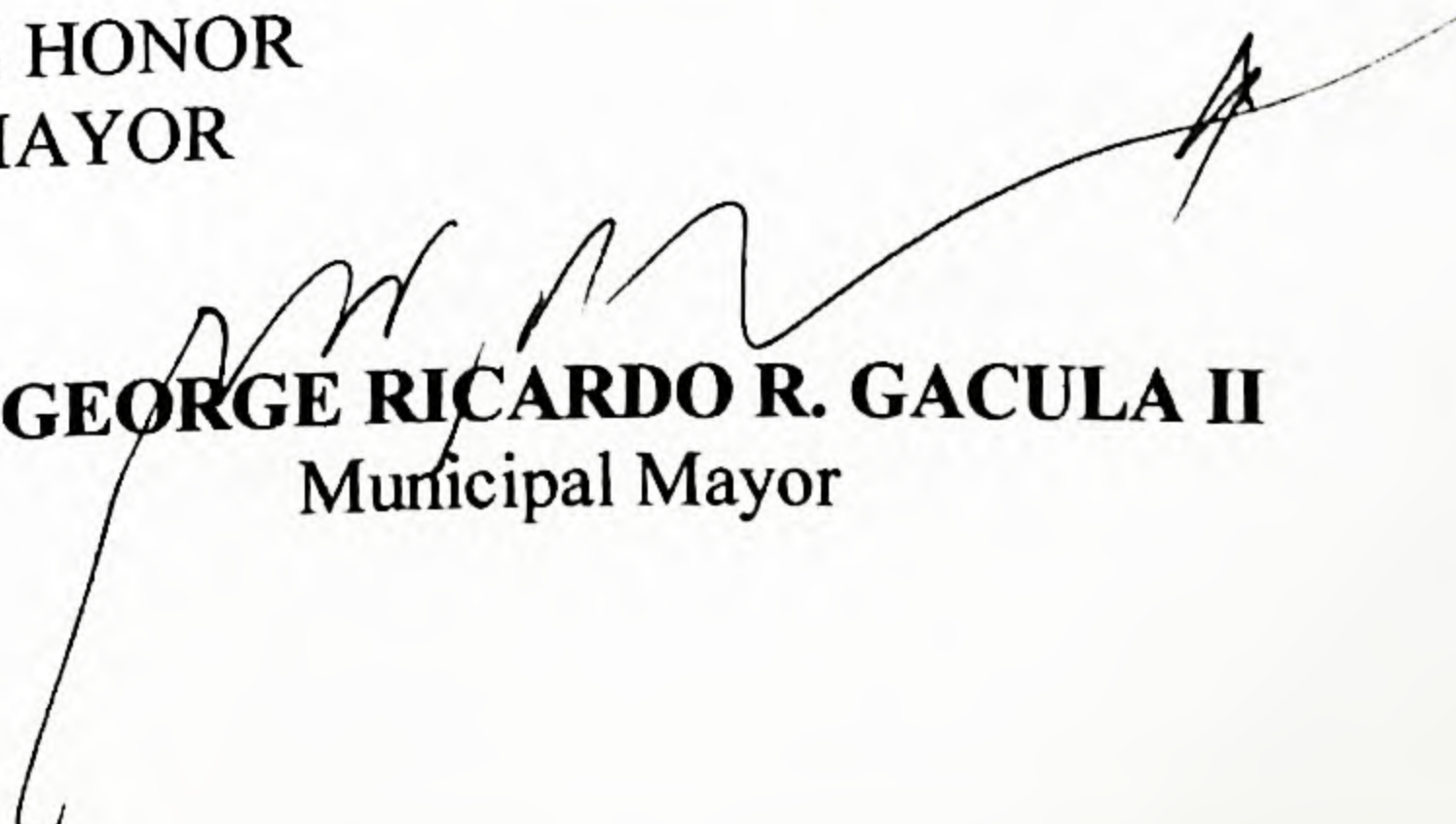
