RESOLUTION NO. 70

**A RESOLUTION TO TEMPORARILY HOLD THE
ISSUANCE OF NEW TODA PERMITS AND NEW
TRICYCLE FRANCHISE IN SELECTED AREAS IN
THE MUNICIPALITY OF TAYTAY, FROM YEAR
2006 TO YEAR 2010**

WHEREAS, RA 7160, otherwise known as Local Government Code of 1991, ART. 3. SEC. 447, (3) (VI), empowers the Sangguniang Bayan (SB) to regulate the operation of tricycles and grant franchise for the operation thereof within the territorial jurisdiction of the Municipality;

WHEREAS, various Tricycle Operators and Drivers Association (TODA) requested to temporarily hold the issuance of new TODA permits and new franchises in this Municipality for 2 to 5 years;

WHEREAS, after consultation with the various TODA, the NAGKAISA (tricycle federation) and Taytay Municipal Tricycle Franchising and Regulatory Board (TMTFRB); the proposition was acceptable, but shall be limited to selected areas, so that those areas which has no tricycle services have chances of having the same.

NOW THEREFORE, the Sangguniang Bayan (SB) in session, duly assembled, adopt as it is hereby adopted the following:

SECTION 1. COVERAGE

The following areas are hereby declared temporarily close for issuance of new TODA permits and new tricycle franchises. Only renewal of terminal permits and franchises shall be allowed, to wit:

ALL TODA's not covered by this resolution shall be covered by the existing rules and regulations. Extensions of tricycle terminals of previously approved TODA's shall be subject for the approval of the TMTFRB;

SECTION 2. DURATION

This resolution shall be effective until December 31, 2010.

SECTION 3. IMPLEMENTING AGENCY

The Taytay Municipal Tricycle Franchising and Regulatory Board (TMTFRB) and the License Department are mandated to oversee the effective implementation of this resolution;

SECTION 4. EFFECTIVITY

This resolution shall take effect immediately upon approval.
