OF HIS PROPERTY LOCATED AT SORRENTO STREET, SAN

WHEREAS, Mr. Faustino De Castro is the rightful owner of a lot located at Lot No. 2, Block No. 27 Sorrento Street, San Francisco Village, Barangay Muzon, Taytay, Rizal with the Transfer Certificate of Title No. 215156;

WHEREAS, there is a 15 Square Meter encroachment of the existing road to the property of Mr. Faustino De Castro;

WHEREAS, the concreting of road at Sorrento Street was funded by the Rizal Provincial Government;

WHEREAS, it is the duty and responsibility of the Local Government to give our constituent a just compensation in acquiring private property for public use or purposes;

Gacula II, to enter into negotiation with Mr. Faustino De Castro for the purchase of his property located at Sorrento Street, San Francisco Village, Barangay Muzon, Taytay, Rizal;

RESOLVED FURTHER, that copies of this resolution be transmitted to all person concern for their information and appropriate action.

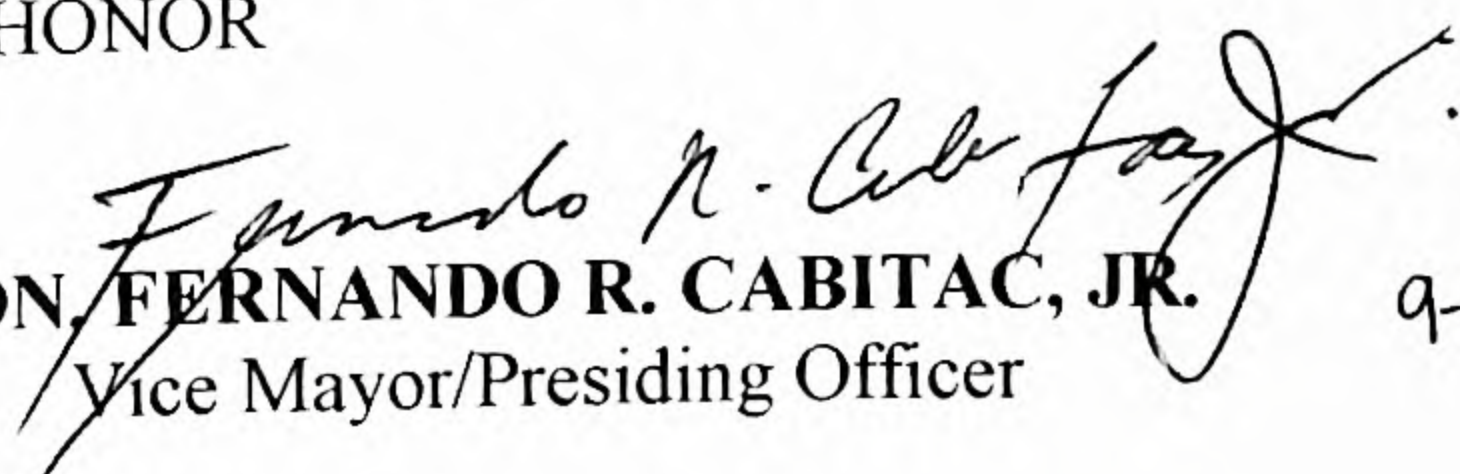

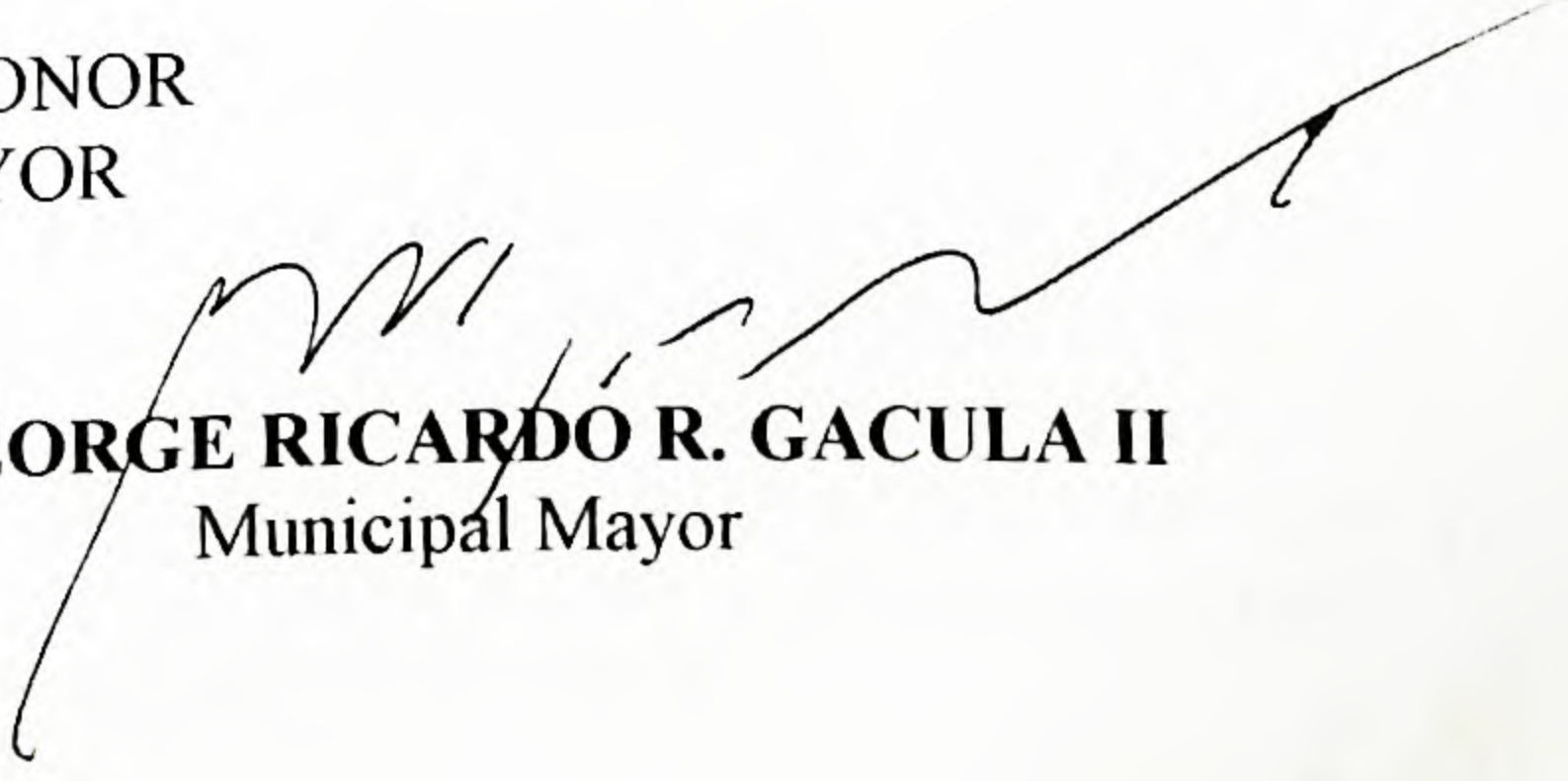
