ADOPTED, this 18th day of September, 2006 at the Session Hall of the Municipal Building, Taytay , Rizal.

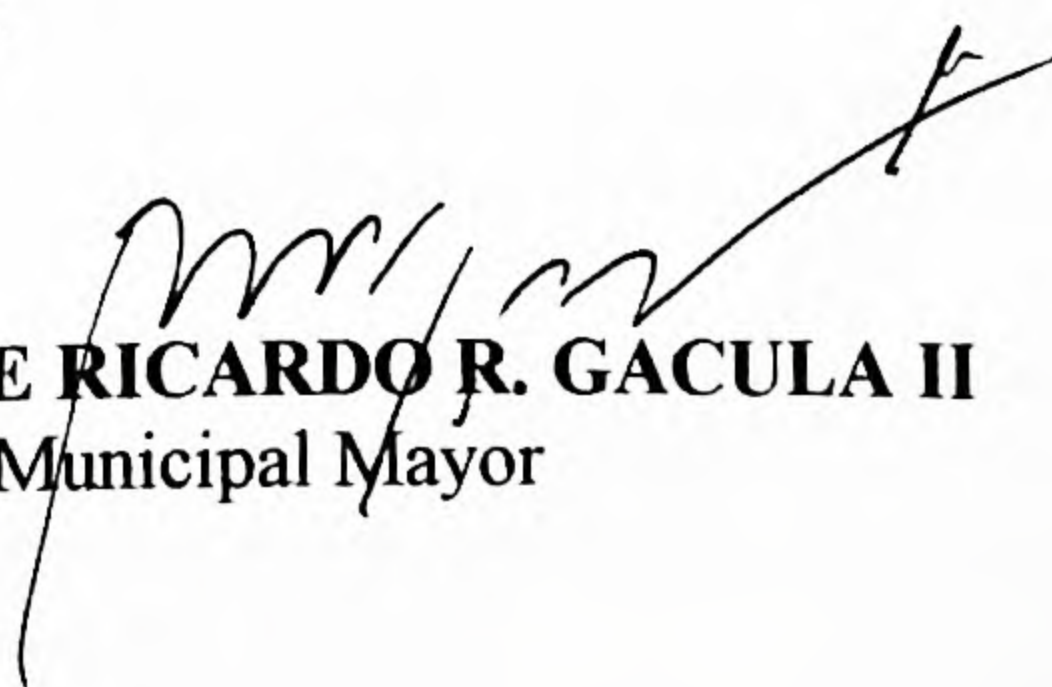
