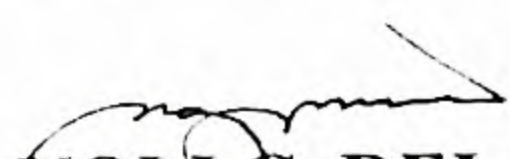

RESOLVED FURTHER, that the DEED OF DONATION between the Municipal Government and Donors be ratified by the Sangguniang Bayan;

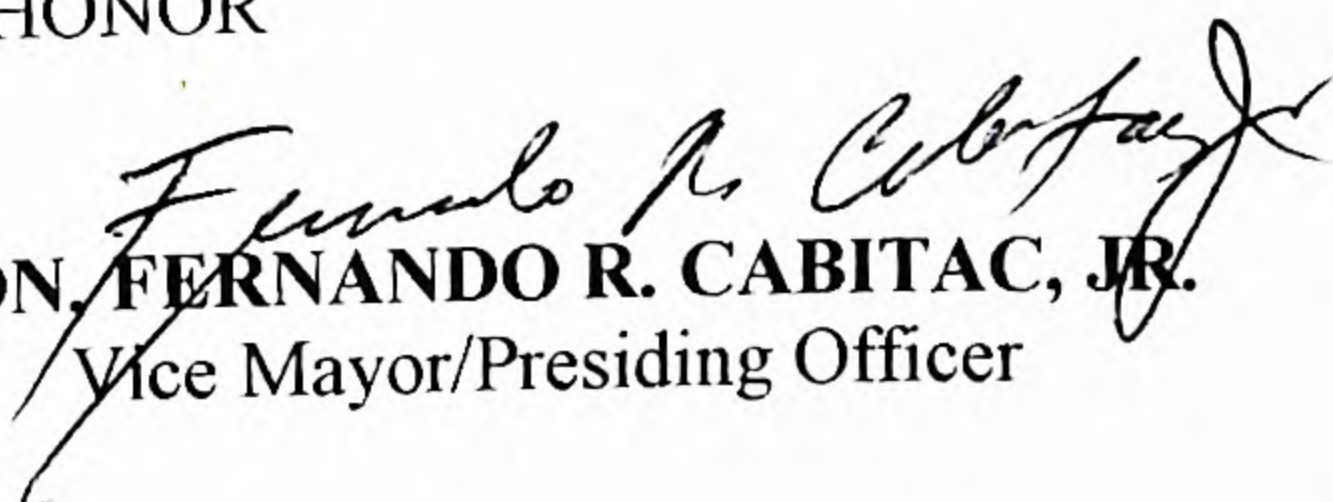
RESOLVED FURTHERMORE, that copy of this Resolution be furnished to all concerned for their information and appropriate action.
