ADOPTED, this 2nd day of October 2006 at the Session Hall of the Municipal Building, Taytay, Rizal.

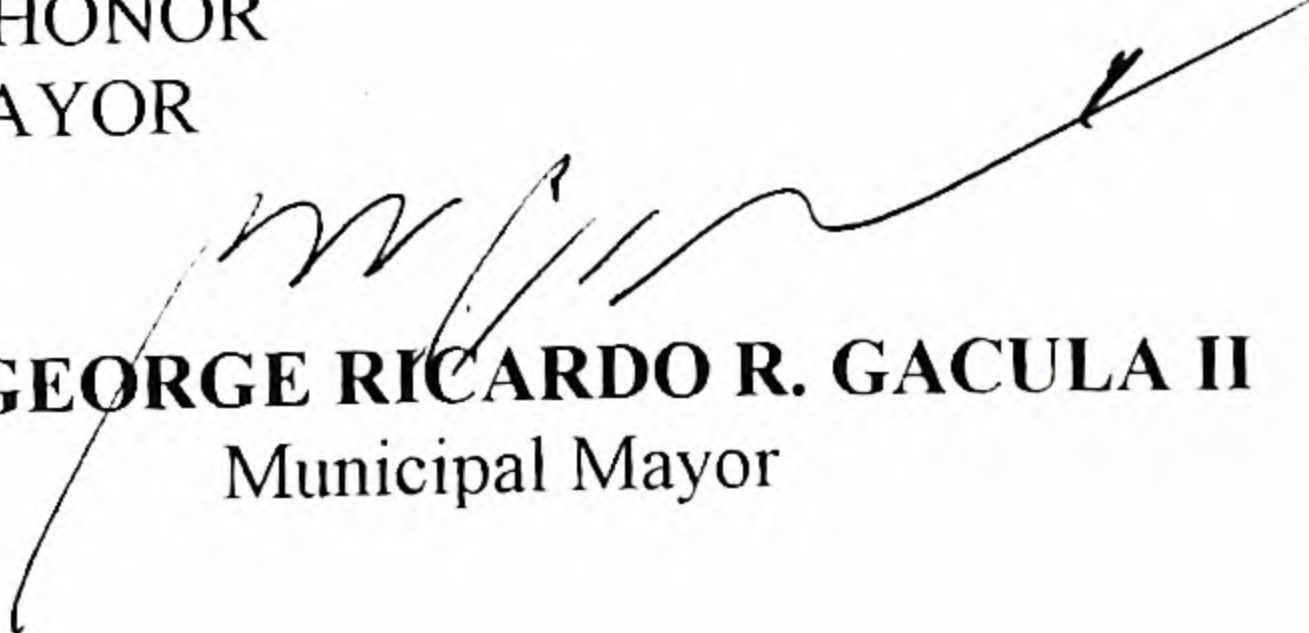
