RESOLUTION NO. 79

**A RESOLUTION FOR THE STRICT IMPLEMENTATION
OF REPUBLIC ACT. 9257 OTHERWISE KNOWN AS "THE
EXPANDED SENIOR CITIZENS ACT OF 2003" AND
ESTABLISHING A PROCEDURE FOR THE DISSEMINATION
OF WHICH IN THIS MUNICIPALITY**

WHEREAS, Republic Act. 9257 also known as "The Senior Citizens Act of 2003" was signed into law supplementing additional benefits and privileges to Senior Citizens thereof;

WHEREAS, the Expanded Senior Citizens Act 2003 grants discount for Senior Citizen purchases on basic commodities and other related goods for their personal consumption;

WHEREAS, Section three (3) of the Implementing Rules and Regulation states that all tricycle, jeepneys should post a Senior Citizens 20% fare discount; Section six (6) states that all establishments must adopt the said provision and provide express lane, discount and Posting of Notice for the implementation of Republic Act 9257; while Section eight (8)

provides Penal Administrative Sanctions to violators of Republic Act 9257 and Administrative Order 37 series of 2005;

WHEREAS, it is responsibility of every Local Government Unit through its Local Chief Executive to ensure that the provision of Republic Act 9257 are operational and implemented in fullest extent within its territorial jurisdiction;

WHEREAS, the Local Office of Social Welfare, thru Office of Senior Citizens Affair, shall coordinate with all recognized senior citizen associations within our municipality, other local agencies concerned all establishments/institutions within our municipality, which were mandated by law, to properly observed the strict implementation of Republic Act 9257, as provided for, by the law;

WHEREAS, attached herewith the necessary documents for the implementation of this Act;

RESOLVED, as it is hereby resolved, that the Sangguniang Bayan of Taytay, in session duly assembled hereby mandates for the STRICT IMPLEMENTATION OF Republic Act. 9257 OTHERWISE KNOWN AS "THE EXPANDED SENIOR CITIZEN ACT OF 2003".

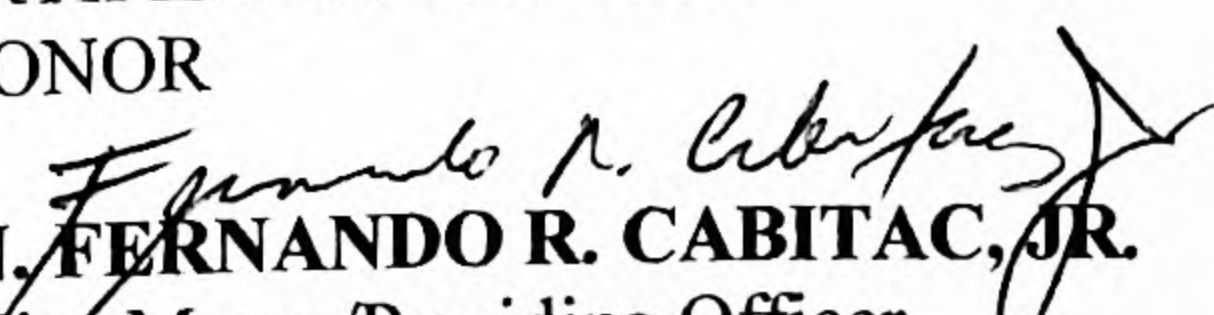
RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and appropriate action.
