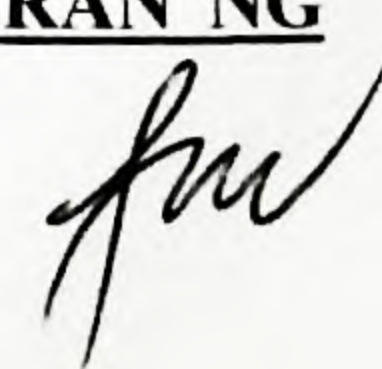
ACCREDITING KAPATIRAN NG ISANG LAHI SA HULONG BANGIAD II ITAAS, INC.

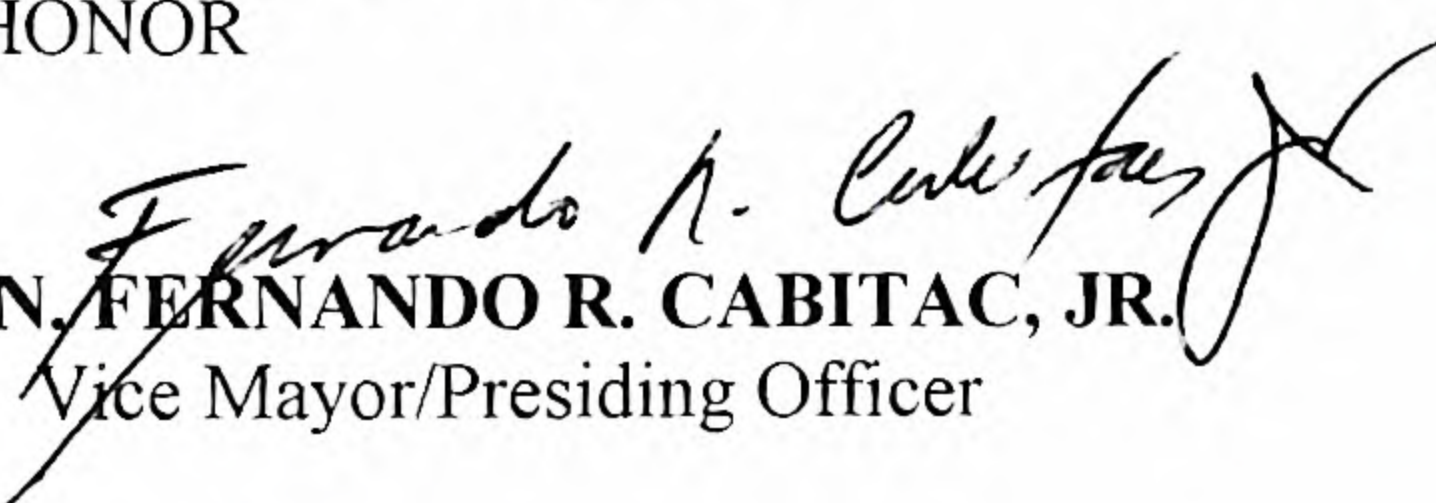

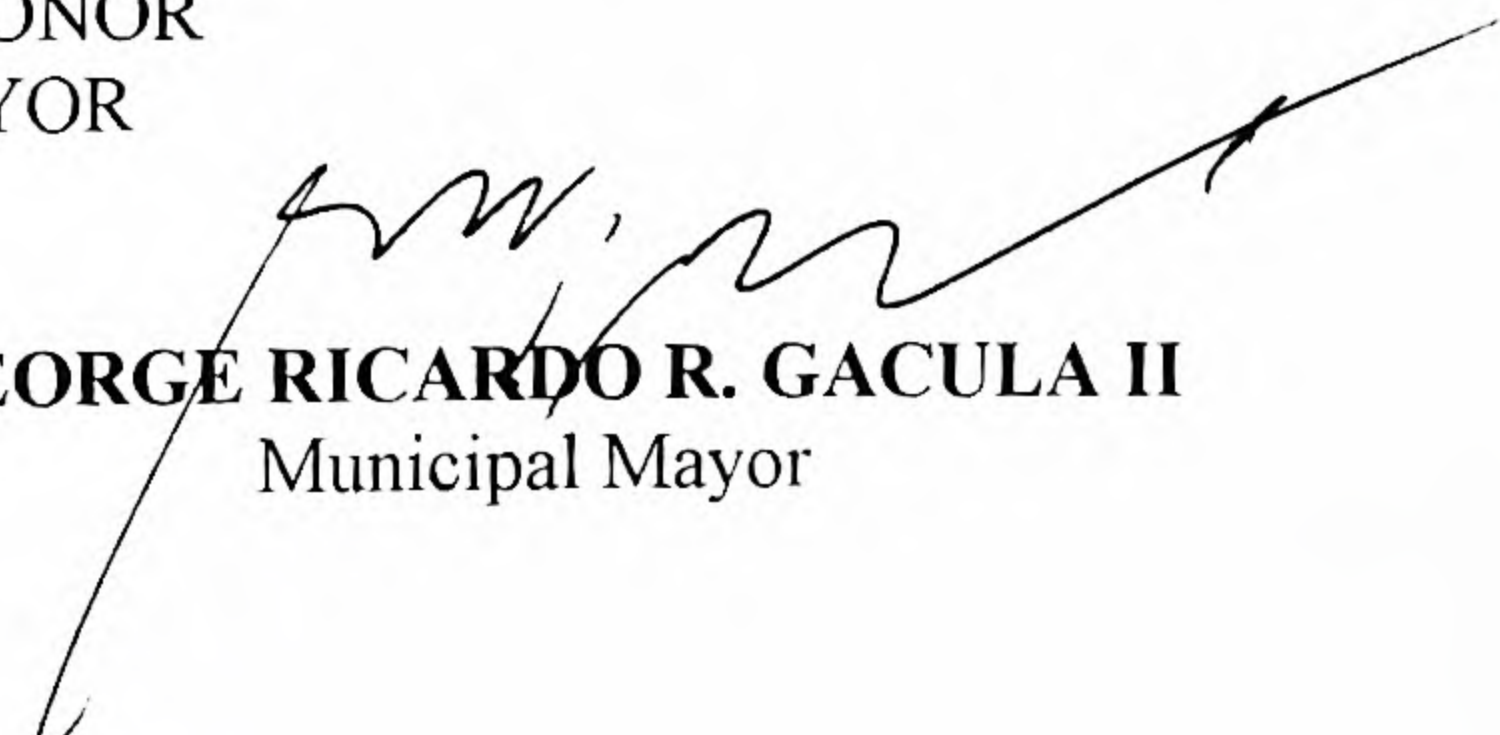
