WHEREAS, the Municipal Government of Taytay applied for service connection and was submitted last September 21, 2006;

WHEREAS, based on the evaluation of MERALCO, there is a need to establish fund for Service Deposit in the amount of SEVEN THOUSAND ONE HUNDRED THIRTY PESOS (P7,130.00) for Manila East Road and EIGHT THOUSAND FOUR HUNDRED EIGHTY PESOS (P8,480.00) for L. Wood St. both located at Barangay Dolores, Taytay, Rizal;

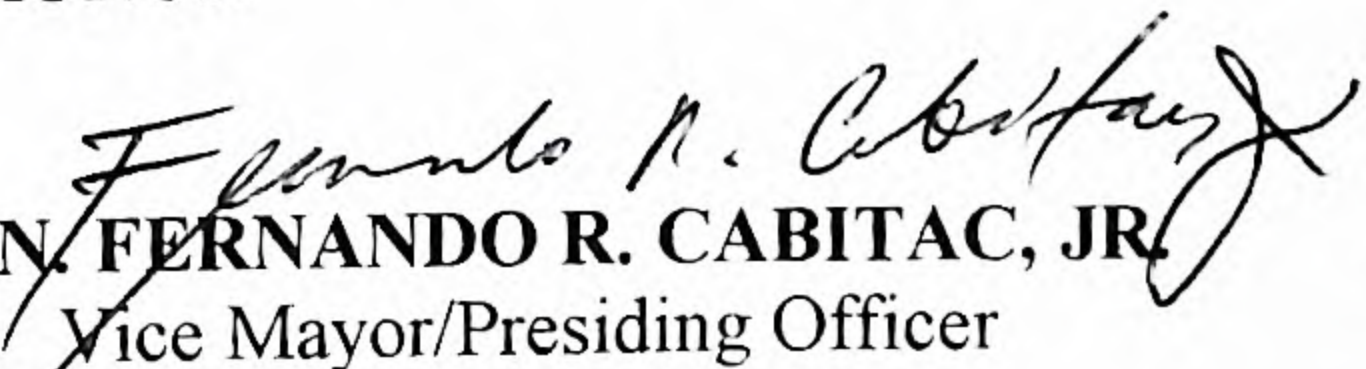
RESOLVED FURTHER, that copies of this Resolution be furnished to all concerned for their information and appropriate action.

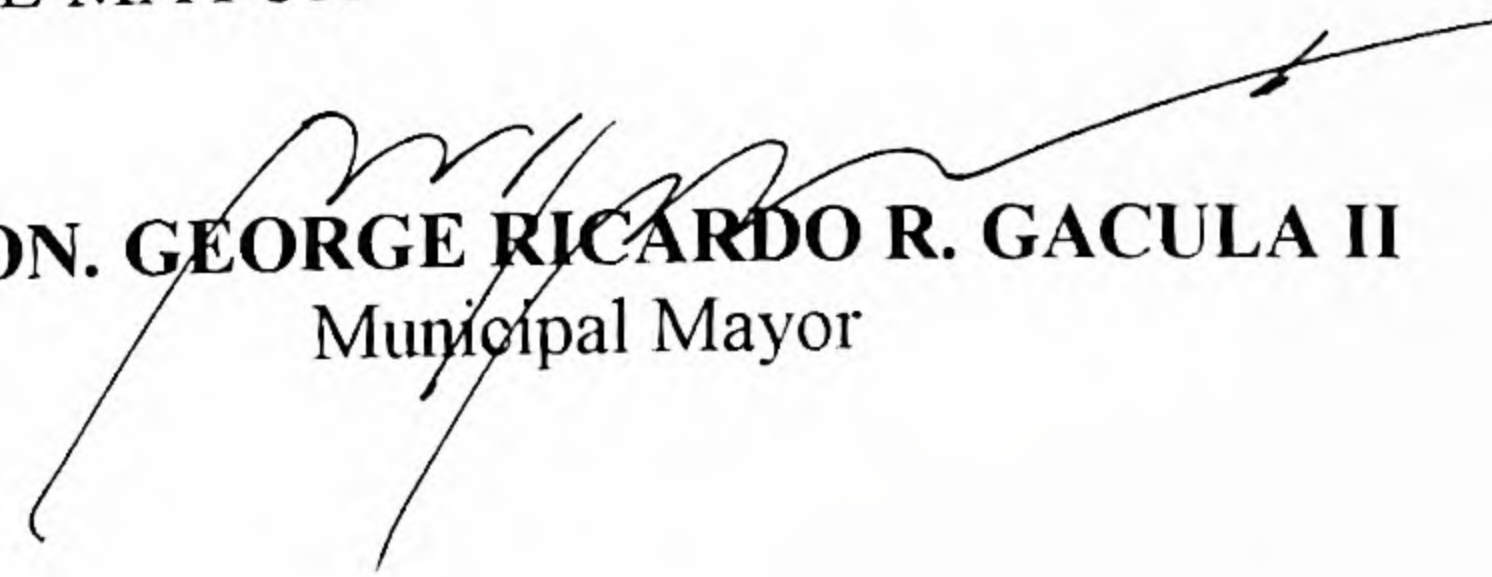
