RESOLVED FURTHER, that this copy be furnished to all concerned for their information and appropriate action.

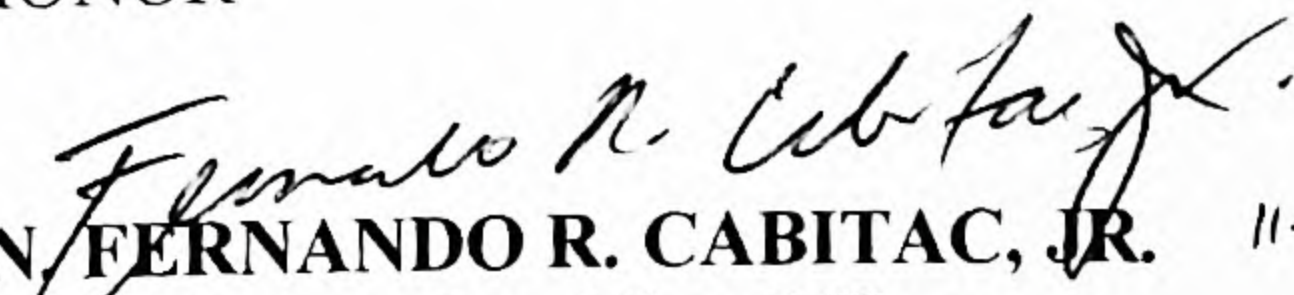

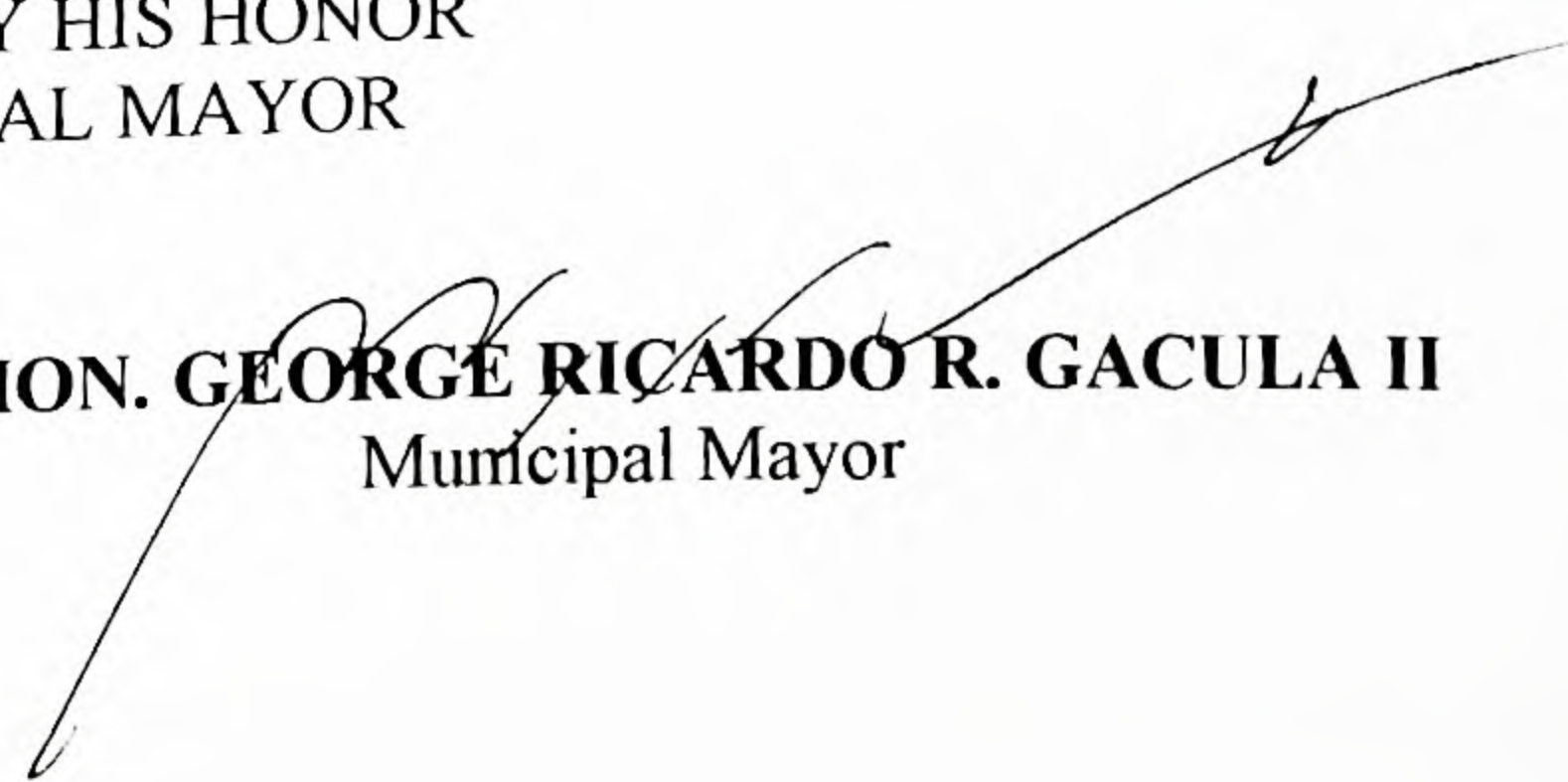
