**A RESOLUTION RESPECTFULLY REQUESTING THE LAGUNA LAKE
DEVELOPMENT AUTHORITY (LLDA), THRU ITS GENERAL MANAGER,
JAIME C. MEDINA, TO TEMPORARILY ALLOW AND GRANT THE NEEDED
CLEARANCE, IF NECESSARY, FOR THE USE OF A PORTION OF LOT,
PARTICULARLY LOT 1, COVERED BY ORIGINAL CERTIFICATE OF TITLE
NO. 2020000071, AND SITUATED AT PUROK 7, BARANGAY STA. ANA, THIS
MUNICIPALITY, AS PLANTING SITE FOR URBAN GARDENING PROGRAM
DURING THE PANDEMIC BY ALLIANCE OF PEOPLES ORGANIZATION IN
LUPANG ARENDA (APOLA)**

WHEREAS, the public health crisis that is currently gripping the country continue to devastate our local economy and has wrought untold suffering to many of our residents especially the vulnerable sectors of our society;

WHEREAS, amidst this crisis, government response to cushion the impact of the crisis were conceptualized and implemented, to include urban gardening through which raising of vegetable crops is encouraged by the government;

WHEREAS, the Laguna Lake Development Authority (LLDA) an attached agency of the Department of Environment and Natural Resources, was conferred with powers and functions to regulate and monitor activities in Laguna de Bay Region;

WHEREAS, quite recently, the Sangguniang Panlalawigan of Rizal adopted a Resolution No. 499 S. 2021 whereby all individuals, corporations or entities are strongly enjoined to plant vegetables and/or establish backyard gardening for self-sustenance and adherence to YES to Green Program of Rizal Provincial Government;

WHEREAS, Urban Gardening is an innovative concept which would enable the residents to raise and culture vegetables and other agricultural crops within one's backyard or in any available open space accessible and suitable for agriculture;


WHEREAS, the portion of the open lot at Purok 7, Lupang Arenda may best serve as the temporary site for Urban Gardening which the Municipal Government can support and assist as a way providing livelihood to the residents of the municipality;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved by the 11th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby RESPECTFULLY REQUESTS THE LAGUNA LAKE DEVELOPMENT AUTHORITY (LLDA), THRU ITS GENERAL MANAGER, JAIME C.
