WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the *Local Government Code of 1991*, mandates every Local Government Unit (LGU) to promote health and safety, preserve the comfort and convenience of its inhabitants, and ensure the general welfare within their respective jurisdictions;

WHEREAS, residents, businesses, and visitors of the municipality rely heavily on telecommunication services for essential communication, including but not limited to mobile phone services, internet access, and emergency response capabilities; and

WHEREAS, the Sanggunian has been receiving a growing number of reports of areas within the municipality with weak to no signal for GLOBE users including but not limited to:

- a. Taytay Tiangge area (within Club Manila East Compound), Brgy. San Juan
- b. Barkadahan Bridge Junction
- c. Portions of Golden City and Cherryville Subdivision, Brgy. Dolores
- d. Portions of Sitio Bato-Bato, Brgy. Dolores
- e. Portions of Manggahan Floodway, Brgy. Sta. Ana and Brgy. San Juan
- f. Portions of Lupang Arenda, Brgy. Sta. Ana
- g. Portions of San Lorenzo Ruiz, Brgy. San Juan
- h. Noel's Village, Brgy. Dolores
- i. Portions of Damayan Floodway, Brgy. San Juan

WHEREAS, the quality of telecommunications service is critical for economic growth, public safety, and overall community wellbeing as it impacts the quality of business services, internet access, and emergency communications;

WHEREAS, these signal issues result in dropped calls, slow internet speeds, poor connectivity, and significant disruption to daily life and business operations;


WHEREAS, the Municipal Government is open to working closely with GLOBE Telecommunications to identify solutions, streamline the approval process for new infrastructure, and ensure that residents receive reliable service the soonest possible time;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 13th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby HUMBLY REQUESTS GLOBE TELECOM INC., TO PROVIDE ASSISTANCE TO THE MUNICIPAL GOVERNMENT OF TAYTAY IN ADDRESSING POOR TO NO SIGNAL IN VARIOUS AREAS WITHIN THE MUNICIPALITY.
