WHEREAS, the Philippine Statistics Authority ("PSA") has developed an updated software, the Philippine Civil Registry Information System ("PhilCRIS") to deliver civil registry information management in a new, more user-friendly, and efficient way;

WHEREAS, the PhilCRIS is a software in the Windows version of the Civil Registry Information System ("CRIS DOS version"). This software enables the encoding of relevant information from civil registry documents, storage of vital data, query, and retrieval of encoded records, printing and issuance of certified copies of encoded civil registry documents, generation of transmittal files, data management and maintenance of the local civil registry database;

WHEREAS, the use of PhilCRIS will enable the Local Government Unit to print preview and print directly to the 2007 civil registry forms;

WHEREAS, for and in consideration of the foregoing, the parties agree to the following terms and conditions of the Memorandum of Agreement;

WHEREAS, the Municipal Government of Taytay shall sign and enter into a Memorandum of Agreement with the Philippine Statistics Authority, for the implementation of the Philippine Civil Registry Information System to all Taytayeño constituents;

WHEREAS, consistent with the goal of providing *Serbisyong May Ngiti* to all Taytayeños through prompt and utmost public service, this Sangguniang Bayan Resolution is being issued;




