## **RESOLUTION NO. 15 series of 2025**

A RESOLUTION HONORING AND COMMENDING POLICE LIEUTENANT COLONEL MARLO NILLO SOLERO, POLICE LIEUTENANT ARNULFO A. MENDOZA III, AND THE TWELVE (12) PARTICIPATING PERSONNEL OF THE TAYTAY MUNICIPAL POLICE STATION FOR THEIR EXEMPLARY OPERATIONAL ACCOMPLISHMENT IN A BUY-BUST **OPERATION** RESULTING IN THE ARREST OF HIGH VALUE INDIVIDUALS AND THE SEIZURE OF PHP 1,020,000.00 WORTH OF SUSPECTED SHABU, AND RESPECTFULLY REQUESTING MAYOR ALLAN MARTINE S. WHEREAS, it is the policy of the State to consistently honor its military and police officers in order to strengthen patriotic spirit and nationalist consciousness;

WHEREAS, Article II, Section 4 of the 1987 Philippine Constitution declares that the prime duty of the Government is to serve and protect the people, and that the Government may call upon the people to defend the State and, in the fulfillment thereof, all citizens may be required, under conditions provided by law, to render personal military or civil service;

WHEREAS, on July 6, 2025, at about 1:05 AM, a buy-bust operation was conducted along Blk. 31, San Lorenzo Ruiz Phase 1, Brgy. San Juan, Taytay, Rizal;

WHEREAS, in response to this critical incident, the Philippine National Police (PNP) Taytay Station, under the leadership of PLTCOL MARLO NILLO SOLERO as Over-all Supervisor, and led by PLT ARNULFO A. MENDOZA III, demonstrated exceptional dedication and professionalism, with key personnel including:

WHEREAS, the operation, led by PLt Arnulfo A. Mendoza III and other members of the anti-illegal drug (buy-bust) operation unit, under the overall supervision of PLtCol Marlo Nillo Solero, resulted in the arrest of:

- Mark Anthony Sarmiento y Corpus aka Bibidu, a 26-year-old male, identified as a High Value Individual (pusher/user),
- John Carlo Aguilar y Alcantara aka Balong, a 20-year-old male, identified as a User/Street Level Individual, and
- Aries Mendoza y Cubedo aka Pusa, a 37-year-old male, identified as a User/Street Level Individual,

for violations of Sections 5 and 11, Article II of Republic Act No. 9165 (Comprehensive Dangerous Drugs Act of 2002) and Republic Act No. 10591 (Comprehensive Firearms and Ammunition Regulation Act);

WHEREAS, during the operation, evidence confiscated from the scene included (5) pieces of heat-sealed transparent plastic sachet of suspected shabu, weighing more or less a total of 150 grams with an estimated Standard Drug Price amounting to Php 1,020,000.00, along with marked buy-bust money, and various other drug paraphernalia and personal effects;

WHEREAS, the success of this operation, which involved twelve (12) participating personnel, including Arresting Officer PCpl Darjay Piandong and Pat Francisco Cervantes II, is a testament to the effective training, inter-agency coordination, and individual bravery of the involved officers;

WHEREAS, through their undaunted courage, prompt action, and unwavering commitment to duty, PLtCol Marlo Nillo Solero, PLt Arnulfo A. Medoza III, and the entire PNP Taytay personnel ensured the safety of the community, swiftly brought the perpetrators to justice, and successfully recovered illegal drugs and firearms, thereby upholding peace and order in Taytay, Rizal;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 13th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby HONORS AND COMMENDS POLICE LIEUTENANT COLONEL MARLO NILLO SOLERO, POLICE LIEUTENANT ARNULFO A. MENDOZA III, AND THE TWELVE (12) PARTICIPATING PERSONNEL OF THE TAYTAY MUNICIPAL POLICE STATION FOR THEIR EXEMPLARY OPERATIONAL ACCOMPLISHMENT IN A BUY-BUST OPERATION RESULTING IN THE ARREST OF HIGH VALUE INDIVIDUALS AND THE SEIZURE OF PHP 1,020,000.00 WORTH OF SUSPECTED SHABU, AND RESPECTFULLY REQUESTS MAYOR ALLAN MARTINE S.
