DE LEON, MPA, TO GRANT FINANCIAL INCENTIVES TO THE TAYTAY MUNICIPAL POLICE STATION

WHEREAS, it is the policy of the State to consistently honor its military and police officers in order to strengthen patriotic spirit and nationalist consciousness;

WHEREAS, Article II, Section 4 of the 1987 Philippine Constitution declares that the prime duty of the Government is to serve and protect the people, and that the Government may call upon the people to defend the State and, in the fulfillment thereof, all citizens may be required, under conditions provided by law, to render personal military or civil service;

WHEREAS, on July 7, 2025, at about 4:20 AM, (reported at 8:30 AM), a robbery with frustrated homicide incident occurred along Blk. 14 Samagta Floodway, Brgy. San Juan, Taytay, Rizal. The victim was identified as Jonariz Gravezo y Mercado, a 24-year-old female. The suspect was identified as JR Diola y Santos, a 38-year-old male, residing at Maharlika St., Brgy. Muzon, Taytay, Rizal. The suspect, armed with a bladed / pointed weapon, approached the victim, stabbed her body, and took her iPhone and immediately fled on foot towards Eastbank Rd. Floodway;

WHEREAS, in response to this critical incident, the Philippine National Police (PNP) Taytay Station, under the leadership of PLTCOL MARLO NILLO SOLERO as Over-all Supervisor, along with other dedicated personnel including PLt Marlon Manook Maiso, PMSg Norberto Silang Umali Jr., PMSg John Relly Aguila Solano, PSSg Edison L. Logmao, PCpl Joselito Bona Gile, PCpl Redgie Tulfo Estrella, and PCpl Mackenray Justiniano Villarazo, demonstrated exceptional dedication and professionalism;

WHEREAS, the aforementioned PNP personnel, upon receiving information about the stabbing incident and verifying the veracity of the report through investigation and CCTV canvassing, immediately launched a hot pursuit operation. At around 9:00 AM on July 7, 2025, a follow-up operation led to the location of the suspect, JR Diola y Santos, in front of the Public Market of Taytay, Rizal;

WHEREAS, despite the suspect's attempt to flee, the PNP personnel involved demonstrated unwavering resolve and skill in pursuing and apprehending him. This decisive action led to the recovery of the victim's stolen phone from the suspect's possession, and the swift turnover of the suspect for proper disposition and investigation;

WHEREAS, through their undaunted courage, prompt action, and unwavering commitment to duty, the PNP Taytay personnel ensured the safety of the community, swiftly brought the perpetrator to justice, and successfully recovered stolen property, thereby upholding peace and order in Taytay, Rizal;


WHEREAS, the successful resolution of this operation, which resulted in the apprehension of a suspect involved in robbery with frustrated homicide, is a testament to the effective training, inter-agency coordination, and individual bravery of the involved officers;


