WHEREAS, the Sangguniang Panlalawigan Resolution No. 408 s. 2025 was passed declaring a State of Calamity throughout the Province of Rizal amid the continuous rains and flooding caused by Tropical Cyclone “Crising” and Southwest Monsoon (“Habagat”);

WHEREAS, Taytay is a Municipality within the Province of Rizal and has been significantly affected by the Tropical Storms “Crising”, “Dante”, and “Emong”, and the southwest monsoon “Habagat”;

WHEREAS, on 23rd of July 2025 the Provincial Disaster Risk Reduction and Management Council (PDRPMC) has approved Resolution No. 06, s. 2025, recommending the declaration of a state of calamity in the Province of Rizal due to heavy flooding and destruction of properties amid the continuous rains caused by Tropical Cyclone “Crising” and Southwest Monsoon (“Habagat”);

WHEREAS, the assessment conducted by the PDRPMC indicated substantial damages to agricultural lands, residential areas, roads, bridges and other critical infrastructure, necessitating immediate and comprehensive response efforts;

WHEREAS, the declaration of a state of calamity enables the Local Government of Taytay and the Barangays as well as the Private Sector to access emergency funds, resources and assistance to respond to and mitigate the effects of the calamity;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 13th Sangguniang Bayan of Taytay, Rizal, in a session duly assembled, hereby **ADOPTS THE DECLARATION OF A STATE OF CALAMITY THROUGHOUT THE PROVINCE OF RIZAL THROUGH SANGGUNIANG PANLALAWIGAN RESOLUTION NO. 408 S. 2025.**


RESOLVED FURTHER, that the Municipality of Taytay shall take all necessary measures to respond to and mitigate the effects of the calamity, including but not limited to: Providing

emergency assistance to affected residents, Conducting damage assessment and needs analysis, Coordinating with provincial and national authorities for support and resources, and Implementing measures to prevent further damage and risks.


RESOLVED FURTHERMORE, that this Resolution shall take effect immediately and shall remain in effect until the state of calamity is lifted by the Sangguniang Panlalawigan of Rizal or the Local Government of Taytay.
