A RESOLUTION REQUESTING MERALCO, TELECOMMUNICATION COMPANIES, INTERNET SERVICE PROVIDERS, AND OTHER SIMILAR ENTITIES TO IMMEDIATELY REMOVE NON-FUNCTIONING OR ABANDONED WIRES AND CABLES WITHIN THE MUNICIPALITY OF TAYTAY, RIZAL AND REQUESTING THE LOCAL CHIEF EXECUTIVE TO FORM A TASK FORCE TO MONITOR THE CLEARING OF ALL NON-FUNCTIONING WIRES

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that every local government unit shall exercise powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare of its inhabitants;

Whereas, the presence of non-functioning, dangling, and abandoned electrical wires, telecommunication cables, and internet lines poses risks to public safety, urban cleanliness, and aesthetic value of the community, as well as hinders disaster response and urban mobility;

WHEREAS, the general welfare of the citizens includes the right to a safe, clean, and orderly environment free from hazards brought about by old and inoperative utility cables or wires;

WHEREAS, the Municipal Government has received multiple complaints from residents and barangay officials regarding such dangerous and unsightly conditions on public roads, alleys, and open spaces;

WHEREAS, the Task Force may include the following offices: Municipal Engineering Office, Business Permit and Licensing Office, Municipal Public Safety Department, Liga ng mga Barangay and other offices that the Office of the Municipal Mayor may identify;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 13th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, hereby REQUESTS MERALCO, TELECOMMUNICATION COMPANIES, INTERNET SERVICE PROVIDERS, AND OTHER SIMILAR ENTITIES TO IMMEDIATELY REMOVE NON-FUNCTIONING OR


ABANDONED WIRES AND CABLES OPERATING IN THE MUNICIPALITY OF TAYTAY, RIZAL AND REQUESTS THE MAYOR TO FORM A TASK FORCE TO LEAD THIS OPERATION.

RESOLVED FURTHER, that the Municipal Engineering Office be directed to coordinate with the concerned service providers for the proper compliance with this request and to submit a report to the Sangguniang Bayan within sixty (60) days from the effectivity of this Resolution.


RESOLVED FURTHERMORE, that a copy of this Resolution be furnished to all associated offices and parties concerned for their information and appropriate action.
