WHEREAS, the active participation of all Sangguniang Kabataan units across the Municipality of Taytay, Rizal is vital to ensuring a meaningful and impactful observance of Linggo ng Kabataan;

NOW THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the 13th Sangguniang Bayan of Taytay, Rizal, in session duly assembled, to DECLARE THE CELEBRATION OF LINGGO NG KABATAAN 2025 IN THE MUNICIPALITY OF TAYTAY, RIZAL FROM AUGUST 11, 2025 TO AUGUST 16, 2025 UNDER THE OFFICIAL THEME: “LOCAL YOUTH ACTIONS FOR THE SDGS AND BEYOND”.

RESOLVED FURTHER, to enjoin all Sangguniang Kabataan units in the Municipality of Taytay, Rizal to actively participate in the observance thereof, coordinate with the Taytay Youth Development Office, and implement local programs and activities that embody the 2025 theme.


