WHEREAS, the Taytay Development Council (TDC) shall assist the Sanggunian Bayan (SB) in setting the direction of development efforts within the municipality;

WHEREAS, on 11 September 2024, the Sanggunian Bayan (SB) adopted and ratified the Annual Investment Program (AIP) for CY 2025 through SB Resolution No. 471 series 2024;

WHEREAS, to comply with the Sangguniang Panlalawigan Committee on Appropriations Findings and Recommendations, to specify the PPAs in 20% Development Fund Source;


RESOLVED FURTHER, that a copy of this Resolution be furnished to all concerned for their information and appropriate action.
