WHEREAS, Section 16 of the General Welfare Clause of RA 7160 provides, in part, that every local government unit shall exercise powers necessary for its efficient and effective governance, as well as those essential to the promotion of the general welfare;

WHEREAS, Section 106 of the Local Government Code of 1991 provides that each Local Government Unit shall have a comprehensive, multi-sectoral development plan to be initiated by its development council and approved by the Sanggunian Bayan;

WHEREAS, the Taytay Development Council (TDC) shall assist the Sanggunian Bayan (SB) in setting the direction of development efforts within the municipality;

WHEREAS, there is an amount of Thirty-Two Million Eight Hundred Forty-Six Thousand Nine Hundred Eighty Pesos and Twenty-Nine Centavos (P 32,846,980.29) available from the Continuing Appropriation under the 20% Development Fund;

WHEREAS, the reversion of funds from the Continuing Appropriation under the 20% Development Fund is deemed necessary in order to utilize the subject funds mentioned above;

WHEREAS, during the Taytay Development Council (TDC) meeting, the members of the council agreed to revert funds from the Continuing Appropriation under the 20% Development Fund, to wit:


